9.4 2005-06 – Sanction of Rs.2 crores to Dharmapuri District

ORDER

In the order first read above, sanction was accorded for Rs.5.00 crores for Dharmapuri District Socio Economic Society to take up certain Socio Economic activities during 2004 to address the Naxalite problem.

2. In the order second read above, sanction was accorded for Rs.5.00 crores to implement the Socio Economic activities in Naxalite affected areas during 2004-05.

3. In the reference third read above, the Director of Rural Development has requested to release Rs.7.00 crores provided in BE 2005-06 for taking up the Socio Economic Development activities under comprehensive development Programme in Dharmapuri District during 2005-06. He has forwarded the Action Plan drawn by the Collector of Dharmapuri District.

4. The Government have examined the matter carefully and decided to accept the proposal of the Director of Rural Development and the Government sanction the release of a sum of Rs.2.00 crores (Rupees two crores only) at the first instance to implement the Socio Economic Development activities under comprehensive Development Programme in Dharmapuri District for the year 2005-06 which can be used proportionately as against items enumerated in the Action Plan. The balance will be considered once the Director of Rural Development has certified the Physical / Financial progress reported by District Rural Development Agency, DPI for funds released in 2005-06.

5. The Expenditure sanctioned in para 4 above should be debited to the following head of account :-

2515-Other Rural Development Programme-102 Community Development Programme in the X Five Year Plan-II State Plan-K1. Programme for Comprehensive Development in Dharmapuri District-09 Grants-in-aid-03 - Grant for Specific schemes (DPC 2515-00-102-K1 0931).

6. The Collector of Dharmapuri District is authorised to draw and place the amount at the disposal of Dharmapuri District Socio Economic Development Society. The amount shall be utilized for the specific scheme drawn in the Action Plan for 2005-06. The utilization of the fund for the specific scheme shall be monitored by Dharmapuri District Socio Economic Development Society & Rural Development Department. The Collector shall furnish the utilization certificates in the prescribed format at appropriate stages to Director of Rural Development for record. He shall also send periodical progress report on utilization of funds and achievements thereon to Director of Rural Development, Planning Development & Special Initiatives Department, Finance Department, Rural Development Department.

7. The Director of Rural Development, shall monitor the progress of the scheme and also maintain the registers on creation of assets etc. as indicated in Tamil Nadu Financial Code Volume-1.

8. This order issues with the concurrence of Finance Department vide their U.O. No.60777/ Rural Development Unit / 05 dated : 31.08.2005.
