- 2. In the letter fourth read above, the Director of Rural Development and Panchayat Raj has sent the Action Plan for the year 2006-2007 drawn by the Collector of Dharmapuri District and requested to release Rs.7.00 crores provided in Budget Estimate 2006-2007 for implementation of Socio Economic Development activities under Comprehensive Development Programme in Dharmapuri District during 2006-2007.
- 3. The Government have examined the matter carefully and decided to accept the proposal of the Director of Rural Development and Panchayat Raj. The amount shall be utilized for the specific scheme drawn in the Action Plan 2006-07.
