

5.9**Extension of Mahalir Thittam to Chennai**

ORDER

In G.O. Ms. No. 19 Social Welfare & Nutritious Meal Programme Department dt.20.02.2001 orders were issued for extension of Mahalir Thittam to all the 6 corporation areas of Chennai, Coimbatore, Salem, Madurai, Tiruchirapalli and Thrunelveli. It was also ordered that the scheme may be extended.

1. Based on the Non Governmental Organisations in the areas and local needs.
2. In Co-ordination with the SJSRY scheme under Municipal Administration & Water Supplies Department, and
3. By incurring the expenditure from the budget for Mahalir Thittam.

2. The Chairperson and Managing Director, Tamil Nadu Corporation for development of Women Limited has stated that the Chennai District has no Project implementation unit at present and that there is a massive urban slum population which will be taken up under the on-going project for which a Project implementation Units is essential. She has also reported that the Dew Review Committee in its meeting on 2.3.2001 has approved the setting up of a Project Implementation unit for Chennai Corporation Area.

3. The Chairperson and Managing Director, Tamil Nadu Corporation for Development of Women Limited has accordingly sent proposal for creation of separate Project Implementation Unit for Chennai District earlier at an estimated cost of Rs.48.78 lakhs during 2001-2002, proposing 16 posts on existing pattern in other Districts. Later proposal was revised to a total costing Rs.58.02 Lakhs.

4. The Government examined the matter in detail. Due to stringent financial position, the government orders that only 3 posts of Assistant Project Officers be employed for Project Implementation Unit for Ma Thi, Chennai District with the condition that all the posts should be filled up on deputation basis and the Department deputing the staff should not fill up the vacant posts arising consequent on the deputation. The Tamil Nadu Corporation for Development of Women Limited should obtain undertaking letter from deputing departments undertaking / boards to the effect. Thus setting up of the Chennai Project Implementation unit with three Assistant Project Officers to start with and some more officers by redeployment without any additional financial commitment. Tamil Nadu Corporation for Development of Women Limited is informed that no additional funds will be provided and it has to manage with the available grant.
