#### ORDER

The Government of Tamilnadu is implementing Entrepreneurship Development Programme Training (EDP) for five lakhs women over a period of 5 years through various departments from 2001-2006 and that Tamilnadu Corporation for Development of Women Limited is the nodal agency to monitor the progress and that a women who has completed this Entrepreneurship Development Programme Training and identified a particular trade, but not possesses the skill, requires Vocational / Skill Training and that as a follow up of Entrepreneurship Development Programme. 3,000 women are imparted Skill Training out of 20,000 Entrepreneurship Development Programme trained women. Apart from this, the Self Help Groups women who could not get a chance to undergo skill as follow up of Entrepreneurship Development Programme Training but requires skill have to undergo Vocational Training in order to earn and support the family.

2. In the Government order, first read above, orders were issued sanctioning a sum of Rs.100.00 lakhs for the implementation of Vocational Training Programme for the year 2003-2004 to 12,500 women of Self Help Groups.

3. The Chairman & Managing Director, Tamilnadu Corporation for Development of Women Ltd., has stated that for the year 2004-2005, a provision of Rs.175.00 lakhs has been made for Vocational Training Programme and by 17,500 women can be trained under this programme and requested the Government to issue necessary orders for sanctioning of Rs.175.00 lakhs towards Vocational Training Programme to 17,500 women in all districts for the year 2004-2005.

4. The Government after careful examination accord sanction to the tune of Rs.100.00 lakhs (Rupees One Hundred Lakhs Only) towards Vocational Training Programme to train 12,500 women in all districts for the year 2004-2005, at the rate of Rs.800/- (Rupees Eight Hundred Only) per beneficiary as was sanctioned in the G.O. first read above.

5. The Director of Social Welfare, Chennai 600 005 is authorized to draw and disburse the amount to Chairman & Managing Director, Tamilnadu Corporation for Development of Women Limited sanctioned in para 4 above.

6. The expenditure sanctioned in para 3 above shall be debited to "2235 Social Security and Welfare - 02 - Social Welfare 103 Women Welfare LN Assistance to Vocational and Skill Training Programme 09 grants in ald 03 grants for Specific Schemes". (DP Code 2235-02-103 LN 0955).
