### EDP Training for 1,00,000 women during 2003-04

#### ORDER

In the Government order first read above orders were issued appointing Tamil Nadu Corporation for Development of Women Ltd. as the Nodal agency for implementation of the Massive – Entrepreneurship Development Programme for five lakhs women for 2001-2006, through which training will be imparted to five lakhs women below poverty line in entrepreneurial skill under EDP, to be followed by necessary skill training in various, select economic activities under Vocational Training Programme and arrangement for credit facilities through commercial Banks etc., so that self employment opportunities are provided.

2. In the Government order second read above orders were issued sanctioning a sum of Rs. 138.95 Lakhs to the Tamil Nadu Corporation for Development of Women Ltd. for the year 2001-2002 to train 20,000 women under EDP, In the Government order third read above orders were issued sanctioning a sum of Rs.166.95 lakhs to the Tamil Nadu Corporation for Development of Women Ltd. for the year 2002-2003 to trained 20000 women under EDP.

3. The Chairperson and Managing Director, Tamil Nadu Corporation for Development of women Ltd. has stated that under the ongoing programme for 2003-2004, the corporation has to train 20000 women under EDP. She has therefore requested the Government to issue orders sanctioning Rs.166.95 Lakhs, with the conditions stipulated in G.O.Ms.No.166, Social Welfare and Nutritious Meal Programme Department dated 29.10.2001. Second read above and relevant instructions thereon for the following items of expenditure:

4. The Government have carefully examined the proposal and accorded sanction for a sum of Rs. 166.95 Lakhs (Rupees One Hundred and Sixty Six Lakhs and Ninety Five Thousand only) to the chairperson and Managing Director, Tamil Nadu Corporation for Development of Women Limited for EDP Training for 20,000 women for 2003-2004 as detailed in para 3 above. The Tamil Nadu Corporation for Development of Women Ltd. Shall follow the due tender procedures as orders issued in para 5 of the Government order second read above.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

“2235 Social Security and Welfare -02 Social Welfare 103. Women’s Welfare  
– BF Entrepreneur Development Training for women -09 Grand in Aid-03.  
Grants for Specific scheme (DPC.No.2235-02-103 BF 0931)”

6. The expenditure sanctioned in para 4 above shall not be paid in cash but shall be contra credited into the following Public Deposit Head of Account:-

“ K- Deposits and Advances.(B) Deposits not bearing interests -8443-00-  
Civil Deposits -800- Other Deposits – AE. Deposits of Government  
Companies, Corporation, etc. 28 Deposits of Tamil Nadu Corporation for  
Development of Women Ltd. (DPC .No.8443 00 800 AE – 2800)”

7. The Director of Social Welfare is authorised to draw the amount sanctioned in para 4 above and contra credit the said amount to the personal Deposit Account, of Tamil Nadu Corporation for Development of Women Ltd. The Director of Social Welfare is directed to get the utilisation certificate and send it to the Government along with the statement of expenditure. Any unspent balance after completion of the training shall be remitted in to Government account.

8. The sum of Rs. 166.95 Lakhs sanctioned in para 4 above shall be drawn in instalments as detailed below:-

August 2003	:	Rs. 60.00 Lakhs
October 2003	:	Rs. 60.00 Lakhs
December 2003	:	Rs. 46.95 Lakhs

9. The EDP scheme is implemented from 2001 -2002. The Government desires that the programme be evaluated by an independent authority like universities or other reputed institutional and the usefulness of the scheme be find out. The CMD, Tamil Nadu Corporation for Development of Women Ltd. is therefore requested to take action on the above lines and sent a report to the Government in the Finance Department before January 04.

The Government direct that the expenditure required for the above study be met form out the amount of Rs. 166.95 Lakhs sanctioned in para 4 above.
