ORDER

In the Government Order first read above, orders were issued appointing TamilNadu Corporation for Development of Women Ltd, as the Nodal Agency for implementation of the massive Entrepreneurship Development Programme for five lakhs women for the year 2001-2006, through which training will be imparted to five lakhs women below poverty line in entrepreneurial skill under Entrepreneurship Development Programme to be followed by necessary skill training in various select economic activities under vocational Training Programme and to make arrangements for credit facilities through commercial Banks etc., so that self employment opportunities are provided. In the Government Order second read above, orders were issued sanctioning a sum of Rs.136.95 lakhs to the Tamilnadu Corporation for Development of Women Ltd., for the implementation of the Entrepreneurship Development Programme Training for the year 2004-05.

2. In the Government order, third read above orders have been issued to impart Entrepreneurship Development Programme Training to another one lakh and fifty five thousand women for the year 2005-2006 and orders were also issued to participate other Departments and to fix the targets of Women trainees for the year 2005-2006 as noted below:-

- 4. The Government have carefully examined the proposal of the Managing Director, Tamilnadu Corporation for Development of Women Limited and approve the scheme for a sum of Rs.243.25 lakhs (Rupees two hundred and forty three lakhs and twenty five thousands only) and sanction is restricted to Rs.166.95 lakhs (Rupees one sixty six lakhs and ninety five thousand only) as per the budget estimate 2005-2006 and the balance of Rs.76.30 lakhs (Rupees Seventy six lakhs and thirty thousand only) have to be met from the source of Tamilnadu Corporation for Development of Women Limited Chennai-32 to Impart Entrepreneurship Development Programme training for 30,000 women for the year 2005-2006. The Tamilnadu Corporation for Development of Women Ltd, shall follow the due tender procedure, as per the orders already issued.
- 5. The Commissioner of Social Welfare, Chennai is authorised to draw the amount sanctioned in para 4 above and contra credit the said amount to the Personal Deposit Account of Tamilnadu Corporation for Development of Women Ltd. The Commissioner of Social Welfare is directed to get the Utilisation Certificate and send it to the Government along with the statement of expenditure. He is also instructed to remit the balance unspent amount, if any into Government Account after completion of the Training.
- 6. The expenditure sanctioned in para 4 above shall be debited to the following head of account.
