In the Government Order first read above, orders were issued appointing Tamil Nadu Corporation for Development of Women Ltd. as the Nodal Agency for implementation of the massive – Entrepreneurship Development Programme for five lakhs women for 2001-2006, through which training will be imparted to five lakhs women below poverty line in entrepreneurial skill under Entrepreneurship Programme to be followed by necessary skill training in various select economic activities under vocational Training Programme and to make arrangements for credit facilities under commercial Banks etc., so that self employment opportunities are provided. In the Government Order second & third read above orders have been issued for the continuance of the above training programme for the year 2001-02 and 2002-03. In the Government order third read above, orders were issued sanctioning a sum of Rs.166.95 lakhs to the Tamilnadu Corporation for Development of Women Ltd. for the year 2003-04.

2. The Chairperson and Managing Director, TamilNadu Corporation for Development of Women Ltd. has stated that previously Entrepreneurship Development Programme Training was given for a period of 7 days and the Entrepreneurship Development Programme Evaluation study conducted by the Tamilnadu State Non Governmental Organisations and Volunteers Resources Centre (TNVRC), which is an autonomous society has recommended to increase the duration of the training from 7 days to 10 days to have more contents in the curriculum like, experience sharing sessions with successful entrepreneurs, to find out the district level feasibility survey on suitable enterprises and marketing strategies. and now it has been decided to extend the training period to 10 day due to which the total expenditure has been increased to 199.95 lakhs and has therefore requested the Government to issue necessary order for sanctioning of Rs.199.95 lakhs with the condition stipulated in the Government Order second cited.

3. The Government have carefully examined the proposal and accord sanction for a sum of Rs.166.95 lakhs (Rupees One Hundred and Sixty Six lakhs and Ninety Five thousand only) to the Chairman and Managing Director, TamilNadu Corporation for Development of Women Limited for Entrepreneurship Development Programme training for 20,000 women for the year 2004-2005. The Tamilnadu Corporation for Development of Women Ltd., shall follow the due tender procedure as orders issued in para 5 of the Government Order second read above.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account :-

5. The expenditure sanctioned in para 3 above shall not be paid incash but shall be contra credited into the following Public Deposit Head of Account

"K-Deposits and Advances (B) Deposits not bearing interests – 8443 – 00 - Civil Deposits – 800 – Other Deposits – AE. Deposits of Government Companies, Corporations, etc. 28 Deposit of Tamilnadu Corporation for Development of Women Ltd." (DPC No. 8443 00 800 AE 2800)

6. The Director of Social Welfare is authorized to draw the amount sanctioned in par 3 above and contra credit the said amount to the personal Deposit Account of Tamilnadu Corporation for Development of Women Ltd. The Director of Social Welfare is directed to get the Utilisation Certificate and send it to the Government along with the statement of expenditure. Any unspent balance after completion of the training shall be remitted in to Government account.
