ORDER

The Chairman, Tamil Nadu Corporation for Development of women Limited has proposed the formation of a IFAD(International Fund for Agricultural Development) assisted Women development in Tamil Nadu. The International Fund for Agriculture Development identification Mission held discussion about this project and a concept to paper was prepared by August 1988. IFAD Foundation Mission after extensive visits in Dharmapuri and Salem Districts held a series of discussions with State Government Officials and prepared ad Memoire outlining the Project approach, component, implementation arrangements, etc. Based on this, the Tamil Nadu Corporation for Development of Women limited prepared a detailed report in October 1980.

- 2. The Project Prepared by the Chairman Tamil Nadu Corporation for Development of Women examined by the Appraisal Mission of IFAD and the Appraisal Mission has estimated the Project Rs.45.8 Crores and the of beneficiaries under this Scheme as 40,350/-
- 3. The draft agreement was discussed in details officials of the Central Government, Secretary, Backward Welfare, Nutritious Meal Programme and Social Welfare Tamil Nadu Government and the IFAD during 3.4.89 to 7.4.89 at draft loan agreement has been drawn up. The executive of IFAD has approved the draft agreement at its meeting 15.4.89 at Rome and the loan agreement was signed by the Ambassdor of the Republic of India to Italy and the President on 30th May 1989 at IFAD in Rome.
- 4 The objective of the project is to improve the economic and social conditions for women in 3 districts. viz., Dharmapuri, Salem and South Arcot of the state of Tamil Nadu to improve their status in the family and the community.
 - 5. The Project Consists of the following parts:-

ECONOMIC ACTIVITIES FOR WOMEN

Through the provision of financial and technical support to establish the following economic activities with a income generation:

1. Farm and Crop Development

- a) On-farm investment in soil reclamation and conservation measures, including land levelling, contour budding and terracing, construction of farm ponds and deepening of wells in selected micro-watersheds.
- b) On-farm investment in water conveyancing and drip irrigation.
- c) Supply of improved inputs and technology to increase production, annual subsistence and cash crops.
- d) Development of agro and Social forestry.
- e) Establishment of orchards and floriculture farm units.
- f) Integrated sericulture including irrigated mulberry leaf production, silkworm culture and improved silk reeling.

2. Livestock Development

Including, inter-alia, calf-rearing, dairying, sheep breeding and fattening, goat breeding and the raising of animals for draft purposes.

3. Cottage and Village Industry Development

Involving the expansion of village level production of simple manufactured goods, principally using agricultural materials and by-products.

PART B: CREDIT

Supply of credit to women to finance income generating activities and also to meet short term consumption and emergencey needs.

- 1. Supply of credit and grant financing through the Tamil Nadu Department of Agricultural Engineering for soil conservation measures undertaken on individual farms as listed inpart A.1(a) above.
- 2. Supply of credit and grant finance through nationalized commercial banks for income generating activities Listed in Part A.1(b) to 1(F) and 2 and 3 above.
- 3. Development of Group saving Funds from beneficiaries contributions and the establishment of a system of savings and loans societies operating at village level, eventually to be linked with other groups/societies, including the provision of approximately US\$ 500,000 as village Capital Development Fund to expand working capital of individual groups.

PART C: DEVELOPMENT OF VILLAGE LEVEL WOMEN'S GROUPS:-

In each selected Project Village the establishment of two or more groups each consisting of 10 to 30 women select as beneficiaries under the Project and designed to act as the organizational catalyst in their economic and social bettering.

PART D: Institutional Support:

- 1. Provision of a management structure with the required field, technical and administrative staff, logistical support and funds to implement the project; monitor and Evaluvate its progress and provide quidelines for future development.
- 2. Support to concerned government departments involved in implementation of Part A of the Project.
- 3. Provision of funds for both formal and in service training of all levels of staff and of beneficiaries.
- 4. Provision of specialist NGO services to assist Project Management with beneficiary selection, group development and the achievement of social objectives.
- 5. Provision of funds for economic and social surveys of group clusters and for marketing and other feasibility studies. The Project is expected to be completed by 31st December 1996.
- 6. DeW shall be the executing agency and shall have all responsibility for the implementation of the Project. Government of Tamilnadu shall ensure that the necessary technical support, required for the implementation of the economic activities taken by the beneficiaries, is provided by respective Tamilnadu line departments, coordinated by the Project Management. DeW Shall engage NGOS acceptable to the Fund to provide social development workers to assist DeW in Project implementation, regarding beneficiary selection, group formation, social development, selection of Supervisors and Village Animators and Training. DeW, shall also engage suitably qualified local consultants to conduct house hold and economic surveys, develop a Management Information system for Monitoring and Evaluation, including adequate training of staff in the use of that system, conduct concurrent evaluations of Project Implementation and conduct market and other special studies related to Project activities.

- 7. The Central Project Co-ordinating committee (CPCC) constituated in G.O. Ms.No.558/BCW, NMP & SWD, dated 20.6.89 under the chairmanship of the Chief Secretary with the State Heads of concerned Line Departments, the authorized Representative of the Bank and Representatives of NGOs associated with the Project members shall be overall authority and co-ordination for the project. District Project co-ordinating Committees (DPCCs) compraising District Heads of concerned Line Departments the authorised Representatives of Lead Bank, Representatives of the concerned NGOs, two elected representatives of the beneficiaries chaired by the Collector, shall be to co-ordinate activities in each district of the Project Area.
- 8. The Project shall be implemented by a Project Management Unit (PMU) which shall be established as a self accounting operational division of District Madras. The chairman of DeW shall be ex-officio Project Director Executive responsibility for Project in the Project co-ordinator of appropriate Seniority on the IAS. Cadre of Tamilnadu. Project Implementation units (PIUs) shall be established in each of the districts of the Project Area and shall be headed by Officers of members of PIUs shall comprise suitably qualified officers from the Line Departments, including agricultural Engineering Agriculture, Horticulture, Sericulture, Animal Husbandry and Officer of the lead Bank. A Marketing officer cum enterperanurship development officer and shall also be appointed by DeW to each district. The first contingent of such officers shall be appointed in Dharmapuri Disrict.
- 9. Village Animators shall be suitably qualified residents of the respective Villages and shall be acceptably the concerned Project women's Groups. Animators and superrisors shall be engaged by Dew on a contract basis and paid allowances the amount of which Government of Tamilnadu shall periodically review and where necessary adjust in under to ensure the engagement and retention of suitable persons. Animators Supervisors shall be engaged on the basis of one Animator village and one supervisor per twelve Animators, in account with a schedule to be mutually agreed and included in the work Programme.
- 10. Villages to be covered under the Project shall selected in clusters of six adjacent villages and in groups of four nearby clusters in order to facilitate supervision. DeW shall be responsible for selecting villages and clusters of and shall take into consideration accessibility to the Branches of the Lead Bank.
- 11. All beneficiaries under the Project shall be the entire income of house hold falls below the recognizing poverty levels defined by the Government of India and revised from time to time. In addition, in respect of the land development activities to be undertaken through the under Part A.1 of the Project these shall only be financed under the Project where land to be developed is held under sole or joint title by women the in selection of beneficiaries, preference shall be given to the poorest women and to women who are de Facto or dejure heads of household.
- 12. DeW shall approve Project beneficiaries from amongst these identified by its NGO workers and who have been found to be credit worthy by the Lead Bank. Beneficiaries to be organized in groups which shall be required to establish autonomous village Savings funds to which members must contribute on regular basis. In order to obtain credit through the lead bank Project beneficiaries shall be required to be financial members of approved groups. They shall have the support of the group with assistance of the Animator and Supervisor in making the applications to the Lead Bank. DeW shall monitor overall performance of group members in credit repayment and in the effective use of credits and shall not recommend future credit under the Project to members of grounds with a poor record.
- 13. DeW shall prepare, in consultation with the Lead Bank and the line departments, an agreed set of operational guidelines including all aspects of Project Implementation,

- including the components. These guidelines shall be provided to the Fund shall be kept informed as to any changes made courses of implementation.
- 14. Under the Project, Credit shall be provided through Lead Bank or such other credit institutions designated with the concurrence of the fund and shall be fully informed on the terms and conditions applicable under the Project.
- 15. In respect of Part B.2 of the Project, the Lead shall maintain credit accounts or beneficiaries in a form that shall permit effective monitoring of individual accounts of project beneficiaries. Quarterly statements of these accounts shall be sumitted to DeW which shall be certify that these are certified beneficiaries under the Project.
- 16. In appraising credit for live Stock development, shall ensure that adequate provision is made for the production and purchase of fodder and that livestock credit shall not be granted in areas where additional livestock are likely to cause to the environment.
- 17. DeW shall administer the grant element of investment charges provided to Project beneficiaries and in respect of part B2 of the Project shall place this money as a fixed-term deposit it in the name of the beneficiary with the Lead Bank to be released to the beneficiary upon repayment of an agreed proportion of the beneficiaries credit. DeW shall examine alternative choice of utilizing the grant funds with a view to implementing alternative procedures under the Project, if necessary, following midterm review.
- 18. In implementing Para A.1 of the Project, DAE shall provide to DeW details of work carried out on individual farm activity and Dew shall ensure beneficiary selection criteria in paragraph 11, above, are fully met.
- 19. Regarding the use of the Village Capital Development provided in category V of Paragraph 1 of Schedule 2 of the Agreement, DeW shall assess individual Group Saving Funds (established under Part B.3 of the Project) after they have been in operation for a period of two or more years and shall release all amounts of additional capital to those funds that have; accumulated sufficient capital by an effective programme of among group members; (ii) a record of effective lending among group members and (iii) been assisted by a approved NGO to an association with other groups to provide overall supervision regular audit of their funds. Detailed guidelines for the detailed guidelines for the operation of the Village capital Development Fund shall be drawn by DeW in consultation with NGOs participating in the project shall be acceptable to the Fund.
- 20. DeW shall prepare an Annual work Programme for the Project, in an agreed format and shall make this available to the fund for its review not less than 45 days before they beginning of each fiscal year. The Annual work Programme shall describe the activities planned for each Part of the Project and shall include estimated expenditures by sources of funding, by components and by category as listed in Paragraph 1 or schedule 2 of the Loan Agreement.
- 21. The three important follow up actions to be undertaken as per the agreement are as indicated below :-
 - 1. Setting up of District and State Level Coordination Committees
 - 2. Appointment of Key Project staff including Project Director, Project Coordinator and Project Officer, Dharmapuri and
 - 3. Engagement of Suitably experiences Non-Government organizations.
- 22. Regarding item (1) referred to in Paragraph 21 above orders have already been issued in G.O.Ms.No.558, Backward Classes Welfare, Nutritious Meal Programme and Social Welfare Department dated 20.6.89. Regarding item (3) in Para 21 above MYRADA, Bangalore has been selected as Non-Governmental Organisation involving implementation of the scheme.

- 23. Regarding item (2) referred to in Paragraph 21 above the Chairman, Tamil Nadu Corporation for Development of Women Limited has since submitted proposal for sanction of staff, furniture, vehicle, machinery, rent and other expenditure for the implementation and monitoring of the project. The Chairman, Tamil Nadu Corporation for Development of Women Limited has stated that during 1989-90 the Project Management Unit at Madras and one Project Implementation Unit at Dharmapuri Would begin functioning.
- 24. The Chairman has also stated that the Project provides for a retro active financing of an amount of Rs.7.50 lakhs to cover the cost of economic potential survey in the initial clusters of villages selected for the Project Implementation, identification of beneficiaries, supporting household surveys and requested orders of the Government allowing the Corporation to incur the above expenditure.
- 25. Regarding audit of accounts of the Project the Chairman has stated that the commercial auditors envisaged under the Companies Act 1955 would be acceptable to IFAD and suggested that this procedure shall be continued in the Project. The government accept this suggestion of the Chairman, Tamilnadu Corporation for Development of women Limited, subject to the acceptance of procedure by the Accountant General, Tamilnadu.
- 26. The Government have examined the proposal of the Tamil nadu Corporation for Development of Women Limited refered to in Paragraphs 23 and 24 above in detail and accept.
- 27. Sanction is accordingly accorded for the employment of staff detail in Annexure I to this order for a period of from the date of employment or till the need therefore whichever is earlier for the implementation and monitoring of schemes.
- 28. The Staff sanctioned in Para 27 above will be eligible for the Dearness Allowance and Other allowances admissible.
- 29. Sanction is also accorded for the incurring of an expenditure not exceedings Rs.28,54,000/- (Rupees Twenty eight and Fifty four thousand only) towards the purchase of machinery such as Computer, MIS software Development, Typewriter, copier, slide Projector, Video Player, Vehicle, Furniture, and Other Expenditure detailed in Annexure II to this order.
- 30. The Government also permit the Tamil Nadu Corporation development of Women Limited to incur an expenditure of 7.50 lakhs (Rupees seven lakhs and fifty thousand) for the purpose mentioned in Para 24 above.
- 31. The Phasing of Project cost by component and activities are indicated in Annexure III to this order.
- 32. The Government authorize the Director of Social Welfare to draw the amount provided for the Project in budget and place it at the disposal of the Project Co-ordinator.
- 33. The expenditure should be debited to "2235 Social Security and Welfare 02 Social welfare 103 Women's Welfare Schemes in the Seventh Five Year Plan II State Plan KV. Tamilnadu Women's Development Project with Financial assistance the IFAD 26 other charges (DP code 2235 02 103 KV 2607)
