The Collector, Dharmapuri is directed to follow the guidelines as given below while implementing the programme.

- 1) IAY Unit cost may be adopted for Construction of New Houses. Village Panchayats should select the beneficiaries from SCs/MBCs/Other communities in the ratio of 40:40:20 and place the list before the Grama Sabha for information. For deciding whether an area is prone to Naxalism, an individual village should not be taken as a unit, but the whole block may be taken as Naxalism-prone.
- 2) For Provision of Revolving Fund and Economic Assistance to Self Help Groups and Economic Assistance to individuals, the SGSY norms of subsidy pattern may be followed.

9. SOCIO-ECONOMIC DEVELOPMENT

Regarding the component of Capacity building for youth, the Collector, Dharmapuri is directed to form a Committee under his Chairmanship and comprising Project Officer, DRDA, Project Officer (Mahalir Thittam), District Employment Officer and Assistant Director (Ex-Servicemen Welfare) to identify the training institutions and also to ensure that the institutions give proper training. This Committee will also act as Monitoring Committee for monitoring the progress and quality of the conduct of training.

KRISHNAGIRI DISTRICT

The Collector Krishnagiri is directed to take up 125 new houses for people in the BPL list in the Blocks which are prone to naxalism in Krishnagiri District using Rs.50 lakhs of Socio Economic Development component for Krishnagiri District. For deciding whether an area is prone to Naxalism, an individual village should not be taken as a unit, but the whole Block may be taken as Naxalism-prone. IAY unit cost may be adopted for construction of new houses under this component and the Village Panchayats should select the beneficiaries from among the SCs/MBCs/Other communities in the ratio of 40:40:20 and place the list before the Grama Sabha for information.
