Training – Tamil Nadu Corporation for Development of Women Limited – Youth Skill training to 25,000 Youth in the age group of 18-35 for the year 2011-12 – Sanction of funds of Rs.15.00 crores – Orders Issued.

ORDER:-

In the Government Order first read above orders were issued sanctioning Rs.56.27 Crores and releasing Rs.26.94 Crores and permitting Rs.2.38 Crores from the savings amount with Tamil Nadu Corporation for Development of Women Limited towards Youth Skill Training Programme for the year 2010-2011.

2. In the letter second read above the Managing Director, Tamilnadu Corporation for Development of Women Limited has stated that Youth Skill Training Programme has been envisaged to reduce poverty by enabling the youth in the age group of 18 to 35 years from poor households to access gainful employment and self employment opportunities, resulting in income on sustainable basis and also visualized to build skills for the job market outside and to nurture self employed and entrepreneurs through micro credit besides pursue skill upgradation and placement prospects through partnership mode as it is one of the best investments in youth and provides impetus to livelihoods opportunities in emerging markets.

3. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has further stated that with this objective in mind, Tamil Nadu Corporation for Development of Women Limited has been imparting skill training to youth through reputed industrial houses and Training Institutions from the year 2006-07 and it is also proposed to train 25,000 youth during the financial year 2011-12 at a cost of Rs.20.00 crores. This provision will be used to impart skill training to 25,000 youth at an average cost of Rs.8,000/- each. It will be ensured that 3% of the total youth trained will be differently abled, 25% belong to Scheduled Tribe, 5% to Transgenders, 3.5% to minorities and balance will be given for others appropriately covering all categories.

4. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has therefore requested the Government to sanction Rs.20,00,00,000/- (Rupees twenty crores only) to Tamil Nadu Corporation for Development of Women Limited for the year 2011-2012 for the implementation of Youth Skill Training programme and to release Rs.10.00 crores as first instalment being the 50% of the amount provided in Revised Budget Estimate 2011-12. She has further requested to authorize the Commissioner of Rural Development and Panchayat Raj, Chennai to draw and disburse the amount to Tamil Nadu Corporation for Development of Women Limited by means of cheque. She has also requested the Government to authorize her to modify guidelines of the scheme in consultation with the Principal Secretary to Government, Rural Development and Panchayat Raj Department based on operational requirements.

5. The Government after careful consideration of the proposal of the Managing Director, Tamil Nadu Corporation for Development of Women Limited, accord sanction and release a sum of Rs.15,00,00,000/- (Rupees Fifteen Crores only) being 75% of the amount available in Revised Budget Estimate 2011-12 towards implementation of Youth Skill Training for the year 2011-12.

6. The amount sanctioned in Para 5 above shall be debited to the following head of account:-

The Government also direct the Managing Director, Tamil Nadu Corporation for Development of Women Limited to ensure that the Youth Skill Training should cover youth who will not get opportunity or coverage under Youth Skill Training Programmes conducted through Tamil Nadu Skill Development Mission and also to ensure that the standard of training is comparable with that of the training imparted through Tamil Nadu Skill Development Mission to make them readily employable either self or wage in Private Institutions.


