#### ORDER:-

In the Government order first read above, the Government had approved the continuance of Mahalir Thittam during the year 2010-11 and distribution of State Level and District Level Bankers awards, Monitoring cost, Marketing, Printing of Self Help Group registers and IEC activities etc.

2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited in her letter second read above has stated that the Mahalir Thittam Programme is implemented in partnership with Non Governmental Organisations and Community- Based Organisations such as Panchayat Level Federations which are affiliated to Tamil Nadu Corporation for Development of Women Limited. The major activities under Mahalir Thittam are social mobilization and formation of Self Help Groups, strengthening of Self Help Group federations, capacity building of Self Help Groups and Community- Based Organisations, credit linkage, promoting micro enterprises of Self Help Groups and documentation. The Tamil Nadu Corporation for Development of Women Limited has proposed to focus on bringing the poor and marginalized sections of the society under Self Help Group movement. Hence it will strive to extend Self Help Group coverage to uncovered areas of the State and uncovered sections of the society and will work towards inclusion of all left out poor

women in Self Help Groups and build their capacity towards social and economic empowerment. Based on this the Annual Plan and Budget for the year 2011-12 for implementation of Mahalir Thittam has been formulated. The Managing Director, TamilNadu Corporation for Development of Women Limited and has furnished the estimated expenditure for carrying out various activities under Mahalir Thittam for the year 2011-12 as detailed below:-

- 3. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has stated that he has sent a separate proposal for Revolving Fund. A sum of Rs.2000.00 lakhs towards Revolving Fund to 20,000 Urban Self Help Groups has been included in the Revised Estimate for Mahalir Thittam continuance Project for Rs.6299.30 lakhs.
- 4. She has therefore requested the Government for sanction of the expenditure of Rs.4847.30 lakhs under Mahalir Thittam for the year 2011-12 as above and also informed that in the Budget Estimate 2011-12, a provision of Rs.6299.30 lakhs is available for the implementation of Mahalir Thittam.
- 5. The Managing Director, TamilNadu Corporation for Development of Women Limited has also stated that Mahalir Thittam activities such as group formation, training and credit linkage are interdependent and have to be taken up simultaneously. Therefore, She has requested the Government to exempt the above expenditure from the purview of quarterly control appropriation. She has also requested the Government to authorize the Principal Secretary to Government, Rural Development and Panchayat Raj Department to amend the guidelines of the schemes based on the operational requirement in consultation with the Managing

Director, TamilNadu Corporation for Development of Women Limited and also authorize her to re-allocate funds among the heads within the overall allocation under Mahalir Thittam. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has requested the Government to approve the expenditure of Rs.4847.30 lakhs for implementation of Mahalir Thittam during 2011-12. She has also requested the Government to authorize the Commissioner of Rural Development and Panchayat Raj, Chennai to draw and disburse the amount of Rs.4299.30 lakhs (Rupees Forty two crores ninety nine lakhs and thirty thousand only) provided in the Budget Estimate for the year 2011-12 to Tamil Nadu Corporation for Development of Women Limited by means of cheque.

- 6. The Government after careful examination of the proposal of the Managing Director, Tamil Nadu Corporation for Development of Women Limited accord sanction and release a sum of Rs.2149.65 lakhs (50% of the amount available in RBE for the year 2011-12) and Permission is accorded to utilize Rs.300 lakhs available with TamilNadu Corporation for Development of Women Limited by way of savings under credit linkage incentive for the Staff, Operating and Investment Cost both for Head Quarters and Project Implementation Units, Monitoring Cost, Marketing activities, Communication activities like printing of Self Help Group Registers and for IEC activities and distribution of Awards to best Self Help Groups /Panchayat Level Federations.
- 7. The Selection of banks / branches of banks for the distribution of Bankers Awards, shall be made as per the parameters and procedures approved by the Government vide G.O.(Ms)No.186, Rural Development and Panchayat Raj Department, dated 22.12.2008.
- 8. The rates of incentive payable to the Non Governmental Organisation / Panchayat Level Federations / Community- Based Organisations for credit linkage is approved as detailed below:-
  - Rs.300/- per Self Help Group on completion of Self Help Group and A&R Training and obtaining of Panchayat Level Federation membership by Self Help Group.
  - b) 0.5% of the credit linkage amount as incentive for the first linkage, 0.75% for second linkage and 1% for 3<sup>rd</sup> and subsequent linkages within 4 years of group formation for bank portion only. The Non Governmental Organisations / Panchayat Level Federation will get incentive for all linkages without any restriction during the 4 years period.
  - c) Rs.2,500/- per Self Help Group as support cost If the Non Governmental Organisation has provided handholding support to the Self Help Group in identification of machines, raw materials, marketing linkage and successful running of the business enterprise of project cost not less than Rs.1.5 lakhs.

- d) The payment of Rs.2500/- will be made subject to the condition that Non Governmental Organisation has given continuous handholding support for economic activity. Self Help Group certification for services offered by Non Governmental Organisation. Repayment of 12 monthly installments of the loan for economic activity without outstanding dues and Documentation of the activity and other reports.
- 9. (a) out of the amount of Rs.2149.65 lakhs (Rupees twenty one crores fourty nine lakhs and sixty five thousands only) sanctioned in para 6, a sum of Rs.1692.69 lakhs (Rupees Sixteen Crores ninety two lakhs and sixty nine thousands only) shall be debited under the following head of account::-
  - "2235 Social Security and Welfare 02 Social Welfare 103 Women's Welfare Schemes in the Eleventh Five Year Plan II State Plan. LC Tamil Nadu Women's Development Project (Mahalir Thittam) 11 subsidies -02 General Subsidy (DPC- 2235- 02-103- LC -1123)
- (b) Out of the amount of Rs.2149.65 lakhs as sanctioned in para 6, a sum of Rs.429.94 lakhs (Rupees Four crores twenty nine lakhs and ninety four thousands only) shall be debited under the following Head of account:-
  - "2235 Social Security and Welfare 02 Social Welfare 789 Special Component Plan for Schedule Castes Schemes in the Eleventh Five Year Plan II State Plan JD Tamil Nadu Women's Development Project (Mahalir Thittam) under Special Component Plan 11 subsidies–02 General Subsidy (DPC -2235- 02-789-JD-1121)
- (c) The balance out of Rs.2149.65 lakhs, Rs.27.02 lakhs (Rupees Twenty seven lakhs and two thousands only) shall be debited under the following head of
  - "2235 Social Security and Welfare 02 Social Welfare 796 Tribal Area Sub-Plan for Scheduled Tribes - Schemes in Eleventh Five year Plan II State Plan JE - Tamil Nadu Women's Development Project (Mahalir Thittam) under Tribal Area Sub-Plan-11 subsidies-02 General Subsidy (DPC- 2235 02-796-JE-1124)
- 10. The Commissioner of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 6 above to the Managing Director, Tamil Nadu Corporation for Development of Women Limited by of Women Limited is requested to send the Utilisation certificate to the Accountant General / Commissioner of Rural Development and Panchayat Raj and Government for record.
