ORDER:

In the Government D.O. letter first read above, the District Collectors  
(p t o)

have been requested to prepare the proposals and send to the Commissioner of Rural Development and Panchayat Raj in conformity with NABARD guidelines for laying of Panchayat and Panchayat Union roads in the needy Village Panchayats.

2) In the letters second and fourth read above, the Commissioner of Rural Development and Panchayat Raj has sent proposals to the tune of Rs.250.92 crores and Rs.201.20 crores respectively and both the proposals were forwarded to NABARD in the Government letter third and seventh respectively read above. Meanwhile, in the letter fifth read above, based on the discussions, the Chief General Manager, NABARD, Chennai, had with the Principal Secretary to Government, Finance Department, the project outlay for laying / upgradation of Panchayat / Panchayat Union roads initially prioritized for Rs.140.00 crores with the assurance from the NABARD that the balance amount would be considered later. Accordingly, in the reference sixth read above a revised proposal has been forwarded to NABARD for sanction of loan.

3) In the letter eighth read above, the General Manager, NABARD, Chennai, has informed that NABARD have accorded sanction for Upgradation / Construction of new 330 Panchayat / Panchayat Union Roads and construction of 3 bridges at an estimated cost of Rs.14367.05 lakhs.

4) Consequent to the sanction accorded by NABARD in the letter eighth read above, the Government after careful examination accord administrative sanction for Upgradation of 330 Panchayat / Panchayat Union Roads and for construction of 3 bridges to the total value of Rs.143,67,05,000/- (Rupees One Hundred and Forty Three Crores Sixty Seven Lakhs and Five Thousand only) for taking up of works indicated in the Annexure to this order with loan assistance from NABARD under Rural Infrastructure Development Fund-XVII (RIDF-XVII) wherein the NABARD's loan component would be of Rs.114,93,64,000/- and the State Government's share would be of Rs.28,73,41,000/-.

5) Out of administrative sanctioned amount of Rs.143,67,05,000/-, financial sanction is accorded for the year 2011-2012 for a sum of Rs.70,73,41,000/- (Rupees Seventy crores seventy three lakhs and forty one thousands only).

5) (a) A sum of Rs.55,73,84,700/- (Rupees fifty five crores seventy three lakhs eighty four thousands and seven hundred only) shall be debited under the following head of account:-

4515 - 00 - CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES - 103 - Rural Development - Schemes in the Eleventh Five year Plan-II State Plan - JC Implementation of Road works in Anaithu Grama Anna Marumalarchi Thittam (AGAMT) Villages under NABARD assistance.

5) (b) A sum of Rs.14,14,68,200/- (Rupees fourteen crores fourteen lakhs sixty eight thousands and two hundred only) shall be debited under the following head of account:-

4515 - 00 - CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES-789 Special Component Plan for Scheduled Castes - Schemes in the Eleventh Five Year Plan - II State Plan - JD implementation of Road works in Anaithu Grama Anna Marumalarchi Thittam (AGAMT) Villages under NABARD assistance under Special Component plan for Scheduled Castes - Controlled by DRD.

5) (c) The balance amount of Rs.84,88,100/- (Rupees eighty four lakhs eighty eight thousands and one hundred only) shall be debited under the following head of account:-

4515 - 00 - CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES-796 Tribal sub-plan - Schemes in the Eleventh Five Year Plan - II State Plan - JA implementation of Road works in Anaithu Grama Anna Marumalarchi Thittam (AGAMT) Villages under NABARD assistance under Tribal sub-plan.

6) The expenditure sanctioned (financial sanction) in para 5 above, will be provided in Revised Estimates / Final Modified Appropriation 2011-12. The Commissioner of Rural Development and Panchayat Raj is requested to send necessary draft explanatory note for bringing the above item of expenditure to the notice of Legislature by specific inclusion in the Supplementary Estimates 2011-12, and to send necessary proposals for inclusion of the expenditure in Revised Estimates/Final Modified Appropriation, 2011-2012.

7) The Commissioner of Rural Development and Panchayat Raj is permitted to execute the works sanctioned in para 4 above utilizing the provision made by NABARD and the share of Government in full and to incur expenditure for Rs.70,73,41,000/- (Rupees Seventy crores seventy three lakhs forty one thousands only) under the heads of account specified in para 5 and its (a), (b) and (c) above and complete the works within the time limit prescribed by NABARD. The Commissioner of Rural Development and Panchayat Raj is also requested to ensure the quality of works as per the standard by issuing detailed instructions to the District Collectors and he is also requested to closely monitor and take follow up action with regard to the quality and timely completion of works as per the standards. He is also directed to ensure that the above works have not been included / undertaken in any of the other schemes before finalizing the tender.
