ORDER :

In the Government D.O.Letter first read above, the District Collectors were requested to prepare the proposals for laying of Panchayat and Panchayat Union roads in the needy Village Panchayats and to send to the Commissioner of Rural Development and Panchayat Raj in conformity with NABARD guidelines.

2) In the letter second and third read above, the Commissioner of Rural Development and Panchayat Raj has sent two sets of consolidated proposals based on the proposals so received from the District Collectors to the tune of Rs.250.92 crores and Rs.201.20 crores respectively and both the proposals were forwarded to NABARD through Finance Department seeking financial assistance for laying of Panchayat and Panchayat Union roads. In the first phase, the NABARD has sanctioned a loan for laying of 330 Panchayat and Panchayat Union Roads and 3 Bridges on a priority basis to the tune of Rs.143.6705 crores under NABARD-RIDF XVII and orders to this effect were issued in the Government order 4th read above. The NABARD has also assured that the loan for laying balance road project would be considered later.

3) In the letter 5th read above, the Commissioner of Rural Development and Panchayat Raj has sent a revised proposal for laying of Panchayat / Panchayat Union roads to the tune of Rs.315.00 crores after excluding the roads which were sanctioned in the Government Order 4th read above and this revised proposal was forwarded to NABARD seeking financial assistance through Finance Department in the letter 6th read above.

4) In the letter 7th read above, the General Manager, NABARD, Chennai, has informed that NABARD have sanctioned loan for laying 637 Panchayat and Panchayat Union roads at the total cost of Rs.315.00 crores under NABARD-RIDF XVII, as indicated in the Annexure sent therein.

5) In the light of the sanction accorded by the NABARD in the letter 7th read above, the Government after careful examination accord administrative sanction for laying/upgradation of 637 Panchayat and Panchayat Union roads to the total value of Rs.315.00 crores (Rupees three hundred and fifteen crores Only) with loan assistance from NABARD under Rural Infrastructure Development Fund-XVII (RIDF-XVII) as indicated in the Annexure to this Order. Of the Rs.315.00 crores, the NABARD's loan component would be of Rs.252,00,00,000/- and the State Government's share would be of Rs.63,00,00,000/-.

6) Out of administrative sanctioned amount of Rs.315,00,00,000/-, financial sanction is accorded for the year 2012-2013 to release a sum of Rs.157,50,00,000/- (Rupees one hundred fifty seven crores and fifty lakhs only)

6) (a) A sum of Rs.124,11,00,000/- (Rupees one hundred twenty four crores and eleven lakhs only) shall be debited under the following head of account:-

4515 - 00 - CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES - 103 - Rural Development - Schemes in the Twelfth Five year Plan - II State Plan - JC Implementation of Road works with NABARD assistance.

6) (b) A sum of Rs.31,50,00,000/- (Rupees thirty one crores and fifty lakhs only) shall be debited under the following head of account:-

4515 - 00 - CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES-789 Special Component Plan for Scheduled Castes - Schemes in the Twelfth Five Year Plan - II State Plan - JD implementation of Road works with NABARD assistance under Special Component plan for Scheduled Castes - Controlled by DRD.

6) (c) The balance amount of Rs.1,89,00,000/- (Rupees one crore and eighty nine lakhs only) shall be debited under the following head of account:-

4515 - 00 - CAPITAL OUTLAY ON OTHER RURAL DEVELOPMENT PROGRAMMES-796 Tribal Area sub-plan - Schemes in the Twelfth Five Year Plan - II State Plan - JA implementation of Road works with NABARD assistance under Tribal sub-plan.

7) Necessary additional funds will be provided in RE/FMA 2012-2013. Pending provision of such funds in RE/FMA 2012-2013, the Commissioner of Rural Development and Panchayat Raj is authorised to draw and disburse the amount sanctioned in para 6. The Commissioner of Rural Development and Panchayat Raj should include the additional expenditure while sending the proposal to Government for inclusion in RE/FMA without fail. However, this expenditure shall be brought to the notice of Legislature by specific inclusion in the Supplementary Estimates 2012-13. The Commissioner of Rural Development and Panchayat Raj is also requested to send necessary draft explanatory notes to Government in Finance (BG-I) Department for inclusion of the Supplementary Estimates 2012-2013.

8) The Commissioner of Rural Development and Panchayat Raj is permitted to execute the works sanctioned in para 5 above utilizing the provision made by NABARD and the share of Government in full and to incur expenditure for Rs.157,50,00,000/- (Rupees one hundred fifty seven crores and fifty lakhs only) under the heads of account specified in para 6 and its (a), (b) and (c) above and complete the works within the time limit prescribed by NABARD. The Commissioner of Rural Development and Panchayat Raj is also requested to ensure the quality of works as per the standard by issuing detailed instructions to the District Collectors and he is

also requested to closely monitor and take follow up action with regard to the quality and timely completion of works as per the standards. He is also directed to ensure that the above works have not been included / undertaken in any of the other schemes before finalizing the tender.
