**ORDER:**

The Commissioner of Rural Development and Panchayat Raj has proposed to purchase 3 Jeeps at a total cost of Rs.17.14 lakhs for providing a Jeep each to the Assistant Directors (Panchayats), Kancheepuram, Erode and Nagapattinam Districts.

2. The Standing Finance Committee has approved the above proposal under Part-II Schemes for the year 2011-2012.

3. Sanction is, therefore, accorded for a sum of Rs.17,14,000/- (Rupees Seventeen lakhs and fourteen thousand only) as non-recurring expenditure for the providing a Jeep each to the Assistant Directors (Panchayats) of Kancheepuram, Erode and Nagapattinam Districts under Part-II Scheme 2011-2012.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of Account:-

2515-00-Other Rural Development Programmes – 001 Direction and Administration I Non Plan – AD Establishment Charges of Assistant Director (Panchayats) and Assistant Director (Audit) – 21 Motor Vehicles – 01 Purchase. (DPC 2515 00 001 AD 2111).

5. The Commissioner of Rural Development and Panchayat Raj, Chennai, is authorized to incur the expenditure the amount sanctioned in para 3 above.

6. The Commissioner of Rural Development and Panchayat Raj shall follow the existing rules in force for purchasing a Jeep each to the Assistant Directors (Panchayats) of Kancheepuram, Erode and Nagapattinam Districts.
