ORDER:

The Commissioner of Rural Development and Panchayat Raj has proposed to purchase 4 Jeeps at a total cost of Rs.22.86 lakhs for providing a Jeep each to the Personal Assistant (Development) to Collectors of Thiruvallur, Erode, Tiruvannamalai and Thiruchirappalli Districts.

- 2. The Standing Finance Committee has approved the above proposal under Part-II Schemes for the year 2011-2012.
- 3.Sanction is, therefore, accorded a sum of Rs.22,86,000/-(Rupees Twenty two lakhs and eighty six thousand only) as non-recurring expenditure for providing a Jeep each to the Personal Assistant (Development) to Collectors of Thiruvallur, Erode, Tiruvannamalai and Thiruchirappalli Districts under Part-II Scheme 2011-2012.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of Account:-
