ORDER:

The Commissioner of Rural Development and Panchayat Raj has proposed to provide modern furniture work with cubicles and make provision for power supply arrangements/LAN cabling for each cubicle in the Directorate for the modernization of Directorate of Rural Development and Panchayat Raj, Chennai-15. The total cost involved for the above scheme is Rs.56.40 lakhs.

- 2. The Standing Finance Committee has approved the above proposal under Part-II Schemes for the year 2011-2012.
