ORDER:

In the Government order first read above, a sum of Rs.1000 crores was sanctioned and released for the construction of 1,00,000 houses in the Thane Cyclone affected districts of Cuddalore and Villupuram. In the above order, 90,000 houses are allotted to Cuddalore District and 10,000 houses to Villupuram District.

2. The Commissioner of Rural Development and Panchayat Raj in his letter second read above has stated that the volume of work of construction of 1,00,000 houses is a gigantic task, which can not be handled by the existing staff, who are already over burdened. The Collector, Cuddalore District has sent a proposal and requested to create Staff Pattern so as to monitor and implement the scheme in a better manner.

3. The Commissioner of Rural Development and Panchayat Raj in the letter second read above while recommending the proposal of the Collector, Cuddalore district has also suggested the mode of filling up of the various posts to be sanctioned. In the letter third read above he has stated that though the posts proposed were for Cuddalore District alone, but after discussions it was finalized taking into consideration both the districts for which houses are sanctioned.

Therefore, he has requested the Government to authorize the Commissioner of Rural Development and Panchayat Raj to make proportionate distribution of posts depending upon the number of houses sanctioned to Cuddalore and Villupuram Districts, without exceeding the total number of posts to be sanctioned by the Government.

4. The Government after detailed examination of the proposal of the Commissioner of Rural Development and Panchayat Raj have decided to sanction for creation of 268 additional posts in various categories as detailed below and to authorize the Commissioner of Rural Development and Panchayat Raj to make proportionate distribution of posts depending upon the number of houses sanctioned to Cuddalore and Villupuram Districts without exceeding the total number of posts sanctioned in this order.

The approval of Legislature will be obtained in due course, pending approval of the Legislature, the expenditure will initially be met from an advance drawn from the contingency fund. The Commissioner of Rural Development and Panchayat Raj is directed to apply for sanctioning of contingency fund in the prescribed form in duplicate to Finance (BG.1) Department, along with the copy of this order. The Commissioner of Rural Development and Panchayat Raj is also directed to send necessary draft explanatory notes to Government in Finance Department for inclusion of this expenditure in the Supplementary Estimates 2012-2013, to obtain the approval of the Legislature at the appropriate time.
