#### ORDER

In the G.O. first read above, Government have issued orders according administrative sanction for the implementation of the Tsunami Emergency Assistance Project (TEAP) with the Asian Development Bank assistance for activities such as restoration of Livelihood of the Tsunami affected poor, rehabilitation of Tsunami damaged roads and bridges, ports and harbours, restoration of water supply and sanitation, rehabilitation of upgrading of Municipal and Rural infrastructure and capacity building and implementation assistance at a cost of Rs.629.63 Crores.

- 2. In the G.O. Second read above, the Govt. have constituted an Empowered committee to clear the projects to be implemented with the assistance of Asian Development Bank.
- 3. In the G.O. third read above, Projects Implementation Unit (PIU) headed by a Project Implementation Officer with supporting staff has been formed.
- 4. The Project Implementing Officer, Tsunami Project Implementation Unit (TPIU) RD Dept., Chennai has sent proposal on Livelihood Component under TEAP assisted by ADB for of Rs.205.25 Crores to Project Director (ETRP &TEAP) for implementation in the Rural Village Panchayats in the Tsunami affected coastal districts.
- 5. The Project Director (ETRP and TEAP) placed the same before the Empowered Committee meeting held on 18.10.05. The Empowered Committee has approved the above proposal for Rs.190.095 Crores.
- 6. The Government, after careful consideration, accept the decision of the Empowered Committee and accordingly sanction a sum of Rs.190.095 Crores (Rupees One Hundred Ninety Crore, Nine lakh and Fifty Thousand only) to Project Implementation Officer, TPIU, Rural Development Dept., Chennai to implement the Livelihood Component

under TEAP assisted by ADB in the Rural Village Panchayats in the Tsunami affected coastal Districts as detailed in the Annexure.

- 7. The Project Implementation Officer, TPIU, Rural Development Dept., Chennai is permitted to make inter-District changes in the allocation based on the needs in consultation with Secretary RD Dept., and Project Director, (ETRP & TEAP). He is requested to adhere the following instructions for the implementation of the Livelihood Project sanctioned above.
- a) Separate guidelines (Project Implementation Manual) covering all aspects of implementation, supervision, monitoring and evaluation, accounting and auditing, review and reporting etc. will be prepared by the PIO. This will cover guidelines relating to the participation of NGOs/ Community in the project implementation, the criteria for selection and other aspects
- b) The guidelines for the implementation of SGSY and such other schemes already in vogue would form a basis for the Livelihood component under TEAP.
- c) Committees at District level, Block level and cluster level shall be constituted for the implementation of this Livelihood component.
- d) Selection of key activities, Training, Marketing strategies, Packaging), developing a common brand name and publicity etc. may be done through the Tamil Nadu Welfare Society for Self Help Groups, NGOs, the Tamil Nadu Corporation for Development of Women and other service providers.
- 8. The expenditure sanctioned in para 6 above shall be debited to following head of accounts:-
- (i) 4515- Capital outlay on other Rural Development Programmes 00 Capital outlay on other Rural Development Programmes 103 Rural Development II State Plan RA works under Tsunami Emergency Assistance Project (TEAP) with assistance from Asian Development Bank-Rural Development Livelihood Programme 16. Major works-

(DPC 4515-00-103-RA-1602) -

Rs.5,00,00,000 (Rupees five crores only)

(ii) 2515 – Other Rural Development Programme – 00 - Other RuralDevelopment Programme – 102 Community Development – II State Plan-RA – Asian Development Bank assisted scheme under Tsunami Emergency Assistance Project (TEAP) – Rural Development – Livelihood Programme – 72 – Training

9. The Project Implementation Officer, TPIU R. D. Dept., Chennai is authorized to draw and disburse the amount to the District Implementation Units. as per the existing procedure and send the Statements of Expenditure, Utilization Certificate and the Progress Reports as laid down by the Asian Development Bank in consultation with the Secretary, Rural Development Department and Project Director (ETRP & TEAP) to execute the works utilizing the provision made by ADB and to incur expenditure under the head of account as specified in para 6 above and complete the works within the time limit prescribed by ADB. The works shall be executed by following the Procurement and other procedures laid down by the funding agency, viz, ADB and in consultation with the Secretary, Rural Development Department and Project Director (ETRP & TEAP). The Project Implementation Officer is requested to ensure that District Implementation Units to obtain all statutory and

environmental clearances applicable for such project and ensure compliance with all the Environmental and Social Assessment Safeguards laid down by the funding agency. The Project Implementation Officer is also requested to ensure the quality of work, by issuing detailed instructions to the field officers. He is also requested to closely monitor and take follow up action with regard to the quality and timely completion of works as per the standards.

- 10. The Rural Development Department shall ensure that other programmes like the programmes implemented by the Pudhu Vazhvu Society, SGSY, etc., are not implemented in the areas where this project is implemented to avoid overlap.
- 11. A sum of Rs.5.00 crores (Rupees five crores only) has been included in the First Supplementary Estimates for 2005-06 under the head of account "4515-00-103-RA-16-Major works" and a sum of Rs.50.00 lakhs under the head of account "2515-00-102-RA-72-00 Training" to meet the expenditure initially. Additional requirement if any needed will be made in RE/FMA 2005-06. The Project Implementation Officer, Project Implementation Unit, Chennai is directed to send necessary proposals to Government for the sanction of additional funds as and when required duly furnishing the Utilization Certificate. The Project Implementation Officer, Project Implementation Unit, Chennai is also requested to include this expenditure while sending proposals for RE/FMA 2005-06 without fail.
- 12. The Project Implementation Officer shall also obtain the Utilisation Certificate from the districts/implementing authorities and send it to Accountant General under intimation to Rural Development / Revenue Department.
