The Executive Director, Tamil Nadu Corporation for Development of Women Ltd., in his letter dated 16.08.04 has stated that during the recent World Bank Mission visit from 29.7.2004 to 5.8.2004, the Task Leader, Ms. Meena Munshi was particular that an Additional Director Level Officer from Rural Development Department should be part of the core team preparing the TNEPRP. She made mention of this Department should be part of the core team preparing the Chairmanship of Chief Secretary. In principle, it was agreed that the post of RD/Institutional Specialist which has been created at the level of Joint Director in the

above read G.O. will be upgraded to the cadre of Additional Director. At present the Joint Director level post of RD Specialist is vacant. The World Bank Mission has included this upgradation and posting of Additional Director as a prerequisite for appraisal. He has also stated that the World Bank Team has also requested to create a new post of CDD & Social Specialist as a key to the proposal. He has therefore requested the Government to issue necessary amendment to upgrade the post of Rural Development Specialist / Institutional Building Specialist to the level of Additional Director and to create the post of CDD & Social Specialist on contractual basis.

- 3. The Government agree to the above proposal of the Executive Director, Tamilnadu Corporation for Development of Women Ltd and in partial modification of the G.O. read above, the Government upgrade the post of Rural Development Specialist or Institutional Building Specialist referred to in SI.No.4 of para 4 of G.O.(Ms.) No.79, Social Welfare & NMP Department, dated 12.05.04 from the cadre of "Joint Director" into "Additional Director". Sanction is also accorded for the creation of the new post of Community Demand Driven and Social Specialist which will be filled up on contractual basis like livelihood specialist, Micro-Finance Specialist as referred to in para 2(a) and 3(2) of G.O.(Ms.) No.79, Social Welfare & NMP Department, dated 12.05.04 as required by the World Bank Mission for the implementation of the Scheme of Tamil Nadu Empowerment and Poverty Reduction Project.
