## ORDER:

The World Bank has forwarded the Aide Memoire of its Mission undertaken to the State of Tamilnadu from July 27<sup>th</sup> to August 3<sup>rd</sup>, 2003 in connection with the proposed Tamil Nadu Empowerment and Poverty Reduction Project. It has been stated in the Aide Memoire that the Government of Tamilnadu will take the following priority actions in order to field their next Mission:-

- a) Establish the Human Development Task Force at the Project Implementation Unit (PIU) Level;
- b) Complete TORs and shortlisting for various preparatory analyses and studies;
- c) Appoint Support Agents/Facilitators and complete the models to be tested through pilots; and
- d) Organise exposure visits for project team to other District Poverty Initiatives Project in India.

The Aide Memoire contains the (1) Project Scope and (2) the project preparation and next steps. The Project Preparation Plan and Time table is given in the Aide Memoire and it consists of

- a) Core Project Preparation Plan
- b) Proposed Project Preparation Activities
- c) Proposed Project Processing Time Table
