ORDER

In the G.O. first read above, the Government have accorded administrative sanction for the implementation of the Tsunami Emergency Assistance Project (TEAP) with the Asian Development Bank assistance for activities such as restoration of Livelihood of the Tsunami affected poor, rehabilitation of Tsunami damaged roads and bridges, ports and harbours, restoration of water supply and sanitation, rehabilitation and upgrading of Municipal and Rural infrastructure and capacity building and implementation assistance at a cost of Rs.629.63 Crores.

2. In G.O. second read above, the Government have constituted an Empowered Committee to clear the projects to be implemented with the grant / assistance from ADB and World Bank.

3. In the G.O. third read above, a Project Implementation Unit headed by a Project Implementatin Officer, Chennai has been formed in Rural Development Department for the implementation of the Externally Aided Projects of Tsunami Emergency Assistance Project (TEAP) funded by Asian Development Bank, Emergency Tsunami Reconstruction Project (ETRP) funded by World Bank and Post Tsunami Sustainable Livelihood Programme (PTSLP) funded by IFAD in the Tsunami affected coastal districts.

4. In the G.O. fifth read above, the Government have sanctioned certain posts for Project Implementation Unit, Rural Development and Panchayat Raj Department, Chennai -1 at State level and for District implementation units at district level under ADB assisted TEAP funds. In the G.O. sixth read above, orders were issued for the continuance of these posts for a further period of two year of the date of completion of these projects whichever is earlier.

5. The Project implementation officer has stated that the sanction of additional staff is required to take up the construction of road works, Public Buildings and Community Infrastructure works of Livelihood Restoration at a cost of Rs.118.25 crores under TEAP sanctioned by the Government Staff already sanctioned under TEAP is inadequate to take up the construction work need above under Public Buildings component of TEAP. The preliminary work of selection of land, survey, plan preparation, concept note preparation, detailed estimates preparation are to be done early to execute the work immediately. To initiate, supervise and execute these works and to ensure the qualitative implementation of these works necessary additional staff is absolutely essential. He has therefore requested to sanction additional staff at a cost of Rs.5.63 Crores. The Officer on Special Duty (Relief and Rehabilitation), Chennai has placed the above proposal before the Empowered Committee.

6.The Empowered Committee in its meeting held on 09.02.2007 directed that the staff proposal of line departments be examined separately by a Sub- Committee with respect to actual

requirements and funds provided under implementation support of the project. The Sub-Committee approved the proposal of the PIO. TPIU restricting, the number of posts as given in the Annexure to this order for execution of schemes by Rural Development and Panchayat Raj Department under TEAP.

7. The Government after careful examination decided to accept the decision of the Sub-Committee and sanction the additional staff at a cost of Rs.166.14 lakhs (Rupees one hundred and sixty six lakhs and fourteen thousand only) detailed in the Annexure to this order for DIUs in Pudukottai, Thanjavur, Ramanathapuram and Tiruvarur Districts for execution of schemes by Rural Development and Panchayat Raj Department under TEAP for a period of one year from the date of filling up of the posts. The expenditure for the posts sanctioned under this Government order will be met from TEAP assisted by Asian Development Bank.

8. The engineering staff and administrative staff shall be on deputation to DIUs. The staffs sanctioned above are eligible to draw their grade Pay and allowances including Project Allowance in accordance with orders admissible in force. Orders on deputation, terms and conditions for the staff shall be issued separately by the respective departments in accordance with the orders in force.

9. The PIO is also permitted to redeploy the sanctioned staff based on the needs of the DIUs in consultation with Secretary to Government, Rural Development and Panchayat Raj, Deparment. The salary and other expenditure including expenditure on schemes shall be disbursed through the District implementation Units.

10. The expenditure sanctioned in paragraph 7 above shall be debited to the following head of account:-
