ORDER:

In the Government order first read above, orders had been issued renaming the “Pudhu Vaazhvu Project” as Vazhndhu Kaattuvom Project, accordingly the scheme was hitherto called as “Vazhndhu Kaattuvom Project”. The State level and District level Societies had also changed the name of the society as “Tamil Nadu Vazhndhu Kaattuvom Society” and “District Vazhndhu Kaattuvom Society”.

2. The Project Director, Tamil Nadu Empowerment and Poverty Reduction Project in his letter second read above has stated that while reviewing the Rural Development and Panchayat Raj Department by the Hon’ble Chief Minister, it was decided to restore the original name for the scheme. Therefore, she has requested the Government to issue necessary orders to re-name the Project as “Pudhu Vaazhvu Project”.

3. The Government have carefully considered the proposal and decided to accept the same and order to restore the name of the Project as “Pudhu Vaazhvu Project” instead of Vazhndhu Kaattuvom Project as the new name for the Tamil Nadu Empowerment and Poverty Reduction Project funded by the World Bank.
