ORDER:

In the Government order first read above among others the Government has established a Capital Grant Fund by replacing the Infrastructure Gap Filling Fund, into which 20 per cent of the aggregate devolution intended for Rural Local Bodies shall be paid. Of this Fund, 20 per cent shall be set apart for taking up projects which are deemed to be of importance at the State level. It has also been ordered that works under this component shall be identified and approved by a Committee comprising of

- 1. The Secretary, Rural Development and Panchayat Raj Department,
- 2. Director of Rural Development,
- 3. A representative of the Finance Department and
- 4. Member Secretary, State Planning Commission.
- 2. Accordingly the Director of Rural Development and Panchayat Raj in the letter 2nd read above has requested the Government to constitute the Committee to identify and approve the works to be taken up from Capital Grant Fund under Fifth State Finance Commission after getting the nomination from Finance Department and also requested to convene the meeting early so as to funding the work from this component.

The Government after careful examination of the proposal of Director of Rural Development and Panchayat Raj at para 2 above, constitute the Committee with the following composition to identify and approve the works to be taken up from Capital Grant Fund under Fifth State Finance Commission at State Level.
 - 1. The Secretary / Additional Chief Secretary, Rural Development and Panchayat Raj Department
 - 2. The Director of Rural Development and Panchayat Raj
 - 3. A representative of the Finance Department (Dr.R.Ananda Kumar, Additional Secretary to Government) and
 - 4. The Member Secretary, State Planning Commission
