ORDER:

In the order first read above Government have issued orders releasing an amount of Rs.3645.40 crore as devolution grant to Village Panchayats, Panchayat Unions and District Panchayats for the months from April 2016 to January 2017.

2. The Director of Rural Development and Panchayat Raj in his letter second read above has stated that Government have made provision in the Budget Estimate 2016-17 for Rs.4806.88 crore as devolution grant to Village Panchayats, Panchayat Unions and District Panchayats. Based on the Budget Estimate 2016-17, the Government have sanctioned and released a sum of Rs.3645.40 Crore as devolution grant to Village Panchayats, Panchayat Unions and District Panchayats for ten months (from April 2016 to January 2017). Subsequently, the provision has been revised to Rs.4361.09 in the Revised Budget Estimate 2016-17. Accordingly, the balance State Finance Commission Grant of Rs.715.69 crore is to be sanctioned for the months of February and March 2017 as detailed below:-

3. The Director of Rural Development and Panchayat Raj has further stated that the Government in G.O. (Ms) No.63, Rural Development and Panchayat Raj (PR-1) Department, dated 06.06.2016 have already sanctioned State Finance Commission Minimum Grant to Village Panchayats and Panchayat Unions for the months of February and March 2017. Whereas the Population based State Finance Commission Grant of Rs.715,69,32,857/-for the months of February and March 2017 have to be sanctioned by the Government as detailed below:-

- 4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue orders to release Rs.715,69,32,857/- (Rupees Seven hundred and fifteen crore sixty nine lakh, thirty two thousand, eight hundred and fifty seven only) as Population Grant of the State Finance Commission Grant for the months of February and March 2017 to Rural Local Bodies. He has also requested the Government to authorize the Director of Rural Development and Panchayat Raj to draw and disburse the amount to the three tier Panchayat Raj Institutions and also to make necessary adjustments/ deductions for committed expenditure such as pension commitment etc.
- 5. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj and sanction a sum of **Rs.581,89,16,857/**-(Rupees Five hundred and Eighty one crore, eighty nine lakh, sixteen thousand, eight hundred and fifty seven only) as State Finance Commission Grant for the year 2016-17 to be distributed to the rural local bodies for the months of February and March 2017 as per 2011 census population.
