## ORDER:

In the Government order first read above, orders were issued accepting the recommendations on the devolution of resources from the State Government to Local Bodies under Fifth State Finance Commission.

- 2. In the Government Order second read above, orders were issued releasing a sum of Rs.295,09,40,500/- out of Rs.590,18,81,000/- as first instalment for the year 2018-19 towards Pooled Fund for Deficit Rural Local Bodies.
- 3. In the letter third read above, the Director of Rural Development and Panchayat Raj has informed that as per the orders second read above, funds have been released from the first instalment amount to Tamil Nadu Water Supply and Drainage Board and Deficit Rural Local Bodies and in respect of 20% of the Pooled Fund vested with Director of Rural Development and Panchayat Raj, the funds will be utilized to provide grants to Village Panchayats and Panchayat Unions who have special problems which cannot be addressed under any of the existing transfer mechanisms or schemes.
- 4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to release the balance amount of Rs.295,09,40,500/- as second instalment under Pooled Fund for Deficit Rural Local Bodies for the year 2018-19.

- 5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj at para 4 above decided to accept the same and accord sanction a sum of Rs.221,32,05,375/- (Rupees Two Hundred and twenty one crore thirty two lakh five thousand three hundred and seventy five only) as a part of second instalment under Pooled Fund for Deficit Rural Local Bodies for the year 2018-19.
- 6. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 5 above and to utilize the amount as per the guidelines issued in the G.O.(Ms) No.94, Rural Development and Panchayat Raj (PR-1) Department, dated 23.08.2017 under Pooled Fund for deficit Rural Local Bodies.
- 7. The expenditure sanctioned in para 5 above shall be debited under the following head of account:-
