### ABSTRACT

### Order:

In the Government order first read above, orders were issued for implementation of the special scheme for provision of basic amenities to Adi-Dravidar Habitations from 2018-19 through Rural Development and Panchayat Raj Department and to utilize Rs. 100 crore required for implementing the scheme during 2018-19 from the Pooled Fund for Deficit Rural Local Bodies for the year 2019-20, vested with Director of Rural Development and Panchayat Raj and District Collector on 50:50 basis and also approved the guidelines for implementation of the Special Scheme of provision of basic Amenities to Adi-Dravidar habitations.

2. The Hon'ble Deputy Chief Minister of Tamil Nadu has made the following announcement while presenting the Budget for the year 2019-2020 in the Legislative Assembly on 8.2.2019:-

“சிறப்புத் திட்டத்தின் மூலம் ஆதி திராவிடர் குடியிருப்புகளில் அடிப்படை வசதிகளை மேம்படுத்துவதற்காக, நடப்பு ஆண்டில் தொடங்கப்பட்ட நடவடிக்கைகளை தொடர்வதற்காக 2019-2020 ஆம் ஆண்டிற்கான வரவு செலவு திட்ட மதிப்பீடுகளிலும் 100 கோடி ரூபாய் ஒதுக்கீடு செய்யப்பட்டுள்ளது.”

3. In the letter third read above, the DRD&PR has sent proposal to Government to implement the special scheme for the Improvement of Basic Amenities in Scheduled Caste Habitations for the year 2019-2020. The DRD&PR has also stated that as per the census of 2011, the rural population of Tamil Nadu is 3.76 crore of which Scheduled Castes (known as Adi Dravidar in Tamil Nadu) are 0.99 crore (24.62%). There are 79394 rural habitations in the State, out of which 1868 have more than 50% Scheduled Caste population and another 20827 have 30 to 50% SC inhabitants.

4. The Director of Rural Development and Panchayat Raj has further stated that for the year 2019-2020, the Government has made a provision of Rs. 100 Crore in the Budgetary estimate of Adi Dravida Welfare Department for the improvement of Scheduled Caste habitation and implement through Rural Development and Panchayat Raj Department.

5. The Director of Rural Development and Panchayat Raj has requested the Government to issue orders on the following:-

(i) to implement the special scheme for the Improvement of Basic Amenities in Scheduled Caste Habitations for the year 2019-2020 at a cost of Rs.100 crore from the State Budget (for Adi Dravidar Welfare Department) through Rural Development and Panchayat Raj Department.

(ii) to permit to implement the Special Scheme of improving the SC habitation and adopt the guidelines issued for the year 2018-19 vide G.O (Ms) No.67, RD&PR(PR.III) Department, dated 4.6.2019 for the year 2019-2020 also.

(iii) to authorize the Director of Adi Dravidar Welfare to draw and disburse the amount to the Director of Rural Development and Panchayat Raj to execute the works as per the guidelines approved in the year 2018-19.

6. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj accord permission for the implementation of the special scheme for the Improvement of Basic Amenities in Scheduled Caste Habitations for the year 2019-2020 at a cost of Rs.100 crore from the State Budget for Adi Dravidar Welfare Department through Rural Development and Panchayat Raj Department.

7. The Government also authorize the Director of Adi Dravidar Welfare to draw and disburse the amount to the Director of Rural Development and
