ORDER:

In the order first read above, Government have issued orders releasing an amount of Rs.3,581,28,34,999 as devolution grant to Village Panchayats, Panchayat Unions and District Panchayats for the months from April 2019 to January 2020.

2. The Director of Rural Development and Panchayat Raj in his letter second read above has stated that in Budget Estimate 2019-20, Demand No.42 of Rural Development and Panchayat Raj Department, the State Government have made provision for Rs.4601.52 crore as devolution grant to Village Panchayats, Panchayat Unions and District Panchayats under the following Head of Accounts:-

3. The Director of Rural Development and Panchayat Raj has further stated that in G.O. (Ms) No.63, Rural Development and Panchayat Raj (PR-1) Department, dated 29.05.2019, the Government have sanctioned and released a sum of Rs.3,581,28,34,999/- as State Finance Commission Minimum Grant to Village Panchayats, Panchayat Unions frcm the month of April 2019 to March 2020 and Population Grant to Village Panchayats, Panchayat Unions and District Panchayats for the months from April 2019 to January 2020 and ordered to release the grant to three tiers on monthly basis on the horizontal sharing ratio.

4. The Director of Rural Development and Panchayat Raj has also added that a total sum of Rs.3,417,54,34,999/- (Rupees Three thousand four hundred and seventeen crore fifty four lakh thirty four thousand nine hundred and ninety nine only) has been released to Rural Local Bodies upto the month of January 2020 comprising of Rs.867,03,00,000/- as Minimum Grant and Rs.2,550,51,34,999/- as Population Grant under State Finance Commission Grant for the year 2019-20 as mentioned below:

5. The Director of Rural Development and Panchayat Raj has further stated that in Dharmapuri District, **Eriyur Panchayat Union** has been newly created from part of the existing Pennagaram Panchayat Urion vide G.O. (Ms) No.127, Rural Development and Panchayat Raj (PR.II) Department, dated: 14.09.2013 and **Kadathur Panchayat Union** has been newly created from part of the existing Morappur Panchayat Union vide G.O. (Ms) No.128, Rural Development and Panchayat Raj (PR.II) Department, dated: 14.09.2013. Further, in Cuddalore District **Srimushnam Panchayat Union** has been newly created from division of the existing Kattumannarkoil, Keerapalayam and Kammapuram Panchayat Unions vide G.O. (Ms) No.97, Rural Development and Panchayat Raj (PR.II) Department, dated: 05.08.2014. As the newly Elected Representatives has assumed offices, the **3 newly created Panchayat Unions** have come into effect from the month of January 2020 onwards and hence the devolution grants have to be released to the above Panchayat Unions.

6. The Director of Rural Development and Panchayat Raj has also stated that the Minimum Grant of Rs.11,64,00,000/- for the month of January 2020 and Rs.38,80,00,000/ for the months of February and March 2020 (2 months) have to be released to 388 Panchayat Unions as mentioned below in S.No.3 and 4 respectively.

The Director of Rural Development and Panchayat Raj has further stated that out of total devolution grant of Rs.1702,56,42,000/- earmarked for Panchayat Unions, a total sum of Rs.154,39,00,000/- have to be allocated as Minimum Grant and a total sum of Rs.1548,17,42,000/- as Population Grant to Panchayat Unions under State Finance Commission devolution grant for the year 2019-20 as detailed below:

Grant to Village Panchayats and Panchayat Unions for the year 2019-20 and to release total sum of Rs.1019,94,14,001/- tcwards the Population Grant of a) Rs.472,61,67,715/- (Rupees Four hundred and seventy two crore sixty one lakh sixty seven thousand seven hundred and fifteen only) to Village Panchayats, b) Rs.442,14,69,143/- (Rupees Four hundred and forty two crore fourteen lakh sixty nine thousand one hundred and forty three only) to Panchayat Unions and c) Rs.105,17,77,143/- (Rupees One hundred and five crore seventeen lakh seventy seven thousand one hundred and forty three only) to District Panchayats for the months of February 2020 and March 2020 under Fifth State Finance Commission for the year 2019-20.

9. The Director of Rural Development and Panchayat Raj has also requested the Government to authorize him to draw the amount of Rs.1019,94,14,001/-(Rupees One thousand and nineteen crore ninety four lakh fourteen thousand and one only) from the above mentioned Head of Accounts and to disburse the amount to three tiers of Panchayats and also to make necessary deductions for committed expenditure such as Solid Waste Management and Pension commitment.

10. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj and release a sum of Rs.376,69,03,001/-(Rupees Three Hundred and Seventy Six Crore Sixty Nine Lakh Three Thousand and one only) as State Finance Commission Grant to Village Panchavats, Panchavat Unions and District Panchayats for the months of February 2020 and March 2020 out of total allocation of State Finance Commission Grant of Rs.3,957,97,38,000/- for the year 2019-20 as follows:-
