## ORDER:-

In the Government order first read above, as per the recommendations of Fifth State Finance Commission, the Government have decided to continue the devolution of 10% of the net State's Own Tax Revenue (SoTR) to Local Bodies based on the recommendations of Fifth State Finance Commission. As per the recommendations of Fifth State Finance Commission, the Government have ordered that the vertical sharing ratio for devolution of State Finance Commission Grant to Rural and Urban Local Bodies will be 56:44 for the Fifth State Finance Commission Award period from 2017-18 to 2021-22.

- 2) The Director of Rural Development and Panchayat Raj in his letter second read above has sent proposals for the release of State Finance Commission Grant to Rural Local Bodies for the year 2019-20 as stated below:-
- i) The State Government have made provision in the Budget Estimate for Rs.6,573,60,70,000/- for the year 2019-20 as detailed below:-

ii) Village Panchayat - Minimum Grant & Population Grant: As per the Fifth State Finance Commission recommendations, the Government have issued orders for the release of Minimum Lump sum Grant of Rs.7.00 lakh per Village Panchayat per annum and this amount will be deducted from the share of State Finance Commission devolution earmarked for Village Panchayats as the first charge and distributed to all Village Panchayats on monthly basis. The balance remaining amount out of the share of Village Panchayats under State Finance Commission devolution will be distributed on the horizontal sharing ratio as mentioned below:-

a)	Total population (2011 Census)	60%
b)	SC/ST population	15%
c)	Area	15%
d)	Per capita consumption expenditure distance	10%

- iii) Panchayat Union Minimum Grant & Population Grant: As per the Fifth State Finance Commission recommendations, the Government have issued orders and release of Lump sum Grant of Rs.40.00 lakh per annum per Panchayat Union and this amount will be deducted from the balance share of State Finance Commission devolution grant earmarked for Panchayat Unions as first charge and distributed to all Panchayat Unions on monthly basis as per the above formula. The balance amount from out of the share of Panchayat Unions under State Finance Commission devolution will be distributed on the horizontal sharing ratio as mentioned at para (ii) above as population grant.
- (iv) District Panchayat Population Grant: As per the Fifth State Finance Commission recommendations, the amount earmarked for District Panchayats will be distributed on the basis of sharing mechanism.
- (v) Capital Grant Fund and Pooled Fund for Deficit Rural Local Bodies: Regarding Capital Grant Fund and Pooled Fund for Deficit Rural Local Bodies, detailed proposals will be sent to the Government separately by the Director of Rural Development and Panchayat Raj.
- 3. The Director of Rural Development and Panchayat Raj has requested the Government to issue orders for release of the share of Devolution Grant to Village Panchayats, Panchayat Unions and District Panchayats in monthly installments from April 2019 to January 2020 as detailed below:

- 4. The Director of Rural Development and Panchayat Raj has also requested the Government to issue orders for the sanction of Minimum Grant of Rs.876,68,00,000/- (Rupees Eight hundred and seventy six crore and sixty eight lakh only) at the rate of Rs.7.00 lakh per year to each Village Panchayat. In respect of Village Panchayats, the minimum grant may be released @ Rs.60,000/- per month from April 2019 to January 2020 for 10 Months and Rs.50,000/- per month for February and March 2020. An amount of Rs.154,00,00,000/- (Rupees One hundred and fifty four crore only) at the rate of Rs.40.00 lakh per year may be released to Panchayat Union. This minimum grant to Panchayat Unions will be released @ Rs.3,00,000/- per month for 10 months from April 2019 to January 2020 and Rs.5,00,000/- per month for February and March as per the recommendations of Fifth State Finance Commission.
- 5. He has also requested that in respect of Village Panchayats, for the Population Grant of Rs.1,181,54,19,285/- (Rupees One thousand one hundred and eighty one crore fifty four lakh nineteen thousand two hundred and eighty five only) and ten months Population Grant to the Panchayat Unions amounting to Rs.1,106,11,72,857/- (Rupees One thousand one hundred and six crore eleven lakh seventy two thousand eight hundred and fifty seven only) and ten months Population grant to the District Panchayats amounting to Rs.262,94,42,857/- (Rupees two hundred and sixty two crore ninety four lakh forty two thousand eight hundred and fifty seven only) and totally Rs.2,550,60,34,999/- towards the Population Grant for all the three tiers of Panchayats from April 2019 to January 2020 may be sanctioned. Totally, an amount of Rs.3,581,28,34,999/- (Rupees Three thousand five hundred and eighty one crore twenty eight lakh thirty four thousand nine hundred and ninety nine only) for the Minimum Grant for three tier Panchayats for 12 months and Population Grant for three tier Panchayats for 10 months may be sanctioned.
- 6. The Director of Rural Development and Panchayat Raj has also requested the Government to issue orders authorizing him to draw and disburse the amount to the three tiers of Panchayat Raj Institutions and also to make necessary adjustments/deductions for committed expenditure such as pension commitment.

7. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj in the light of the orders issued in the Government order first read above and decided to release a sum of Rs.3,581,28,34,999/- (Rupees Three thousand five hundred and eighty one crore twenty eight lakh thirty four thousand nine hundred and ninety nine only) as State Finance Commission Grant to Village Panchayats, Panchayat Unions and District Panchayats for the month of April 2019 to January 2020 out of total allocation of State Finance Commission Grant of Rs.6,573,60,70,000/- for the year 2019-20 as follows:-
