### ORDER:

In the Government order first read above, orders were issued accepting the recommendations on the devolution of resources from the State Government to Local Bodies under Fifth State Finance Commission.

2. In the Government Order second read above, orders were issued releasing a sum of Rs.295,09,40,500/- out of Rs.590,18,81,000/- as first instalment for the year 2018-19 towards Pooled Fund for Deficit Rural Local Bodies.

3. In the Government Order third read above, orders were issued releasing a sum of Rs.221,32,05,375/- as a part of second instalment under Pooled Fund for District Local Bodies for the year 2018-19.

4. In the letter fourth read above, the Director of Rural Development and Panchayat Raj has informed that the entire amount of Rs.516,41,45,875/- so far released by the Government in G.O. (Ms) No.74, Rural Development and Panchayat Raj (PR-1) Department dated 01.06.2018 and G.O. (Ms) No.165, Rural Development and Panchayat Raj (PR-1) Department dated 20.11.2018 has been fully utilized by disbursing to the concerned District Rural Local Bodies.

5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to release the balance amount of Rs.73,77,35,125/- as a part of second instalment under Pooled Fund for Deficit Rural Local Bodies for the year 2018-19.

The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj at para 5 above decided to accept the same and accord sanction for a sum of Rs.73,77,35,125/- (Rupees Seventy three crore seventy seven lakh thirty five thousand one hundred and twenty five only) as a part of final instalment under Pooled Fund for Deficit Rural Local Bodies for the year 2018-19.

The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 6 above and to utilize the amount as per the guidelines issued in the G.O.(Ms) No.94, Rural Development and Panchayat Raj (PR-1) Department, dated 23.08.2017 under Pooled Fund for deficit Rural Local Bodies.

8. The expenditure sanctioned in para 6 above shall be debited under the following head of account:-

3604-00-Compensation and Assignments to Local Bodies and Panchayat Raj Institutions – 200 – Other Miscellaneous Compensations and Assignments – State's Expenditure – BQ Pooled Fund Deficit - Rural Local Bodies – 09 Grants in Aid – 02-Grants for Creation of Capital Assets.
