## ORDER:

In the order first read above, Government have issued orders releasing an amount of Rs.3,245.42 crore as devolution grant to Village Panchayats, Panchayat Unions and District Panchayats for the months from April 2018 to January 2019.

2. The Director of Rural Development and Panchayat Raj in his letter second read above has stated that the Government have made provisions in the Budget Estimate 2018-19 for Rs.4131.32 crore as devolution grant to Village Panchayats, Panchayat Unions and District Panchayats. Based on the Budget Estimate 2018-19, the Government have sanctioned and released a sum of Rs.3245.42 crore as State Finance Commission Minimum Grant to Village Panchayats, Panchayat Unions from the month of April 2018 to March 2019 and Population Grant to Village Panchayats, Panchayat Unions and District Panchayats for the months from April 2018 to January 2019 and the balance State Finance Commission Grant of Rs.885,89,63,143/- crore is to be sanctioned for the months of February and March 2019 as detailed below:-

- 3. The Director of Rural Development and Panchayat Raj has therefore requested the Government to sanction Rs.885,89,63,143/- as Population Grant from State Finance Commission Grant for the months of February and March 2019. He has also requested the Government to authorize him to draw and disburse the amount to the three tier Panchayat Raj Institutions and also to make necessary adjustments/deductions for committed expenditure such as pension commitment etc.
- 4. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj and release a sum of Rs.885,89,63,143/-(Rupees eight hundred and eighty five crore eighty nine lakh sixty three thousand one hundred and forty three only) as Population Grant from the State Finance Commission Grant for the year 2018-19 to be distributed to the Rural Local Bodies for the months of February and March 2019.
- 5. The amount sanctioned in para 4 above shall be debited to the following heads of account-under Demand No:42-02:-
