Rural Development and Panchayat Raj Department – State Finance Commission Grants for the year 2022-23 – Sanction and release a sum of Rs.751,99,77,857/- towards Minimum Grant for Village Panchayats, Panchayat Unions and Population Grant for all three tiers of Panchayats for two months of July 2022 and August 2022 - Orders – Issued.

ORDER:

In the Government Order 1st read above, as per the recommendations of Fifth State Finance Commission, the Government have decided to continue the devolution of 10% of the net State's Own Tax Revenue (SoTR) to Local Bodies based on the recommendations of Fifth State Finance Commission. As per the recommendations of Fifth State Finance Commission, the Government have ordered that the vertical sharing ratio for devolution of State Finance Commission Grant to Rural and Urban Local Bodies will be 56:44 for the Fifth State Finance Commission Award period from 2017-18 to 2021-22.

2. The Government have also ordered to apportion the Devolution Grant of Rural Local Bodies among the Village Panchayats, Panchayat Unions and District Panchayats in the ratio of 55:37:8 and stated that the funds of Rural Local Bodies under Fifth State Finance Commission will be distributed as follows:

3. As per the Fifth State Finance Commission recommendations, the horizontal distribution of State Finance Commission devolution to Rural Local Bodies should be done on the basis of following formula:

4. In the letter 4th read above, the Commissioner of Rural Development and Panchayat Raj has stated that in Budget Estimate 2022-23, the following provisions have made under the head of accounts pertaining to State Finance Commission Devolution Grant for Rural Local Bodies for the year 2022-23 vide Budget Estimate for the year 2022-23, Demand No.42 of Rural Development and Panchayat Raj Department.

- (i) **Village Panchayat - Minimum Grant & Population Grant:** As per the Fifth State Finance Commission recommendations, the Government have issued orders for the release of Minimum Lump sum Grant of Rs.7.00 lakh per Village Panchayat per annum and this amount will be deducted from the share of State Finance Commission devolution earmarked for Village Panchayats as the first charge and distributed to all Village Panchayats on monthly basis. The balance remaining amount out of the share of Village Panchayats under SFC devolution will be distributed on the horizontal sharing ratio as mentioned in para 3 above.
- (ii) **Panchayat Union - Minimum Grant & Population Grant:** As per the Fifth State Finance Commission recommendations, the Government have issued orders and release of Minimum Lump sum Grant of Rs.40.00 lakh per annum per Panchayat Union and this amount will be deducted from the share of State Finance Commission devolution grant earmarked for Panchayat Unions as first charge and distributed to all Panchayat Unions on monthly basis. The balance remaining amount out of the share of Panchayat Unions under State Finance Commission devolution will be distributed on the horizontal sharing ratio as mentioned in para 3 above.
- (iii) **District Panchayat - Population Grant:** As per the Fifth State Finance Commission recommendations, the amount earmarked for District Panchayats will be distributed on the basis of sharing mechanism as mentioned in para 3 above.

5. In the Government Orders 2nd and 3rd read above, the Government have issued orders for Minimum Grant and Population Grant for all the three tiers of Panchayats for the months from January 2022 to June 2022 under the State Finance Commission.

6. The Commissioner of Rural Development and Panchayat Raj has now sent a proposal for release of State Finance Commission Grants for the months of **July 2022 and August 2022** as detailed below:-

The Commissioner of Rural Development and Panchayat Raj has therefore requested the Government to issue orders for the sanction and release a total sum of Rs.751,99,77,857/- (Rupees Seven hundred and fifty one crore ninety nine lakh seventy seven thousand eight hundred and fifty seven only) as detailed at para 6

above towards Minimum Grant for 12,525 Village Panchayats and 388 Panchayat Unions for two months of July 2022 and August 2022 and Population Grant for all the three tiers of Panchayats for two months of July 2022 and August 2022.

8. The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj hereby accord sanction for the release of a sum of Rs.751,99,77,857/- (Rupees Seven hundred and fifty one crore ninety nine lakh seventy seven thousand eight hundred and fifty seven only) as State Finance Commission Grant to Village Panchayats, Panchayat Unions and District Panchayats for the months of July 2022 and August 2022 out of total allocation of State Finance Commission Grant of Rs.5080,87,45,000/- for the year 2022-23.

9. The amount sanctioned in para 8 above shall be debited to the following respective Heads of Accounts:-
