ORDER:

In the recommendations first read above, the Sixth State Finance Commission has recommended for earmarking Capital Grant Fund under the Special Grants for the award period from 2022-23 to 2026-27. The recommendations of the Sixth State Finance Commission have been accepted by the Government in the Government Order second read above. Based on the State Finance Commission recommendation, the Government has constituted a State Level Committee to administer the State Level Grants released under State Finance Commission in Government Order third read above.

2. In the letter fourth read above, the Director of Rural Development and Panchayat Raj has stated as follows:-

- In the Budget Estimate for the year 2024-25, Demand No.42 of Rural Development and Panchayat Raj Department, the Budgetary allocation of Rs.1233.00 Crore has been earmarked for the Capital Grant Fund.

- The first meeting of the State Level Committee to administer the Special Grants under State Finance Commission Grant was convened in 31.05.2023. The committee approved the sanction of special grants under State Finance Commission for the year 2024-25 and accordingly funds are to be released upon orders of the Government.
- The committee approved the dovetailing of funds under Capital Grant Fund for the schemes/agencies as mentioned below in Table-II, in the State Level Committee for administering State Level Grant release under State Finance Commission Minutes of the meeting held on 31.05.2024:-

3. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue orders for the release of Rs.1233,00,00,000/- (Rupees One thousand two hundred and thirty three crore only) towards Capital Grant Fund for the year 2024-25.

4. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj have decided to accord sanction and release the first installment of Rs.616,50,00,000/- (Rupees Six hundred and sixteen crore and fifty lakh only) as being the 50% of total grant under the Capital Grant Fund for the year 2024-25.
