# ORDER:

In the Government Order first read above, orders were issued releasing an amount of Rs.901.75 Crore towards 50% of Basic Grant Untied Component as first instalment for the year 2020-21 under the Fifteenth Central Finance Commission and to utilize the Basic Grant in conformity with the guidelines issued by Government of India.

- 2. In the letter 2<sup>nd</sup> read above, the Ministry of Finance, Department of Expenditure, Government of India, has released a sum of Rs.901.75 Crore towards 50% of Rural Local Bodies Tied Grant as first installment for the year 2020-21 recommended by the Fifteenth Finance Commission.
- 3. In the reference third read above, the Director of Rural Development and Panchayat Raj has stated that the Ministry of Finance, Government of India in its letter dated 01.06.2020 has stated that a sum of Rs.3607.00 crore has been allocated as Rural Local Body Grants for the year 2020-21 under 15<sup>th</sup> Central Finance Commission for Rural Local Bodies in Tamil Nadu. Out of this Rs.1803.50 crore is sanctioned as Tied Grant and Rs.1803.50 crore as Untied Grant.

4. He has also stated that necessary provisions have been made in Budget Estimate 2020-21 separately for Tied Grant and Untied Grant under the following head of accounts pertaining to 15<sup>th</sup> Central Finance Commission Grant for Rural Local Bodies for the year 2020-21.

The Director of Rural Development and Panchayat Raj has further stated that the Ministry of Finance, Government of India in its release order dated 17.06.2020 has released an amount of Rs.901.75 Crore towards 50% of Basic Grant Untied Component as first Installment for the year 2020-21 under the 15<sup>th</sup> Central Finance Commission Grant and same has been released to rural local bodies in G.O. (Ms) No.116, Rural Development and Panchayat Raj (PR-1) Department, dated 25.06.2020. The Fifteenth Finance Commission has recommended that the Grants for Rural Local Bodies (RLBs) are in two parts, namely, Basic and Tied Grants, in the ratio of 50:50.

#### The Basic Grant:

Basic Grants are untied and can be used by Rural Local Bodies for locationspecific felt needs, except for salary or other established expenditure.

### The Tied Grant:

Tied Grant is to be used for the basic services of a) Sanitation and maintenance of Open Defecation Free (ODF) status and b) Supply of drinking water, Rain water harvesting and recycling. The Local bodies shall, as far as possible earmark one half of these tied grants each to these two critical services. However, if any local body has fully saturated the needs of one category, it can utilize the funds for the other category. The Fifteenth Finance Commission has also recommended that its Grant, Basic and Tied, should be distributed to all the tiers of the Panchayats in the States on the basis of the accepted recommendation of the latest State Finance Commission (SFC) and also in conformity to the bands recommended by XV FC. In this context, the following sharing/Distribution formula have been approved by the Government in letter No.6156/PR-1/2020-3, dated 26.05.2020 in respect of Rural Local Bodies in Tamil Nadu.

- The vertical sharing ratio among three tiers of Rural Local Bodies will be 5:15:80 for District Panchayats, Panchayat Unions and Village Panchayats respectively.
- Horizontal Distribution of Fifteenth Finance Commission Grant within the tier will be as per the Horizontal Distribution formula as recommended by Fifth State Finance Commission formula given below:

a)	Population as per 2011 census	: 60%
b)	Area	: 15%
c)	SC/ST population	: 15%
d)	Per capita consumption	
25	Expenditure Distance	: 10%

- 6. The Director of Rural Development and Panchayat Raj has also stated that the Ministry of Finance, Government of India in its release order dated 15.07.2020 has released an amount of Rs.901.75 crore towards 50% of Rural Local Bodies Tied Grant as First instalment for the year 2020-21 under the 15<sup>th</sup> Central Finance Commission Grant and ordered to transfer the above grant amount within ten working days of receipt from the Union Government without any deduction.
- 7. He has therefore requested the Government to release an amount of Rs.901,75,00,000/- (Rupees Nine Hundred and One Crore and Seventy Five Lakh only) towards 50% of Rural Local Bodies Tied Grant as first instalment for the year 2020-21 under Fifteenth Finance Commission and to authorize him to draw and disburse the above amount to 12,525 Village Panchayats and 388 Panchayat Unions and 36 District Panchayats. The detailed State specific guidelines will be issued comprehensively for both tied and untied components after the issuance of Government of India guidelines on Tied grants.

- 8. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj accord sanction for a amount of Rs.901,75,00,000/- (Rupees Nine Hundred and One Crore and Seventy Five Lakh only) towards 50% of Rural Local Bodies Tied Grant as first instalment for the year 2020-21 as recommended by Fifteenth Central Finance Commission.
- 9. The expenditure sanctioned at para 8 shall be debited to the following heads of account:-

The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned at para 8 above immediately to the 12,525 Village Panchayats and 388 Panchayat Unions and 36 District Panchayats without any delay so as to avoid penal interest. The Director of Rural Development and Panchayat Raj is directed to follow the operational guidelines issued by the Ministry of Finance in its letter No.15(2)FC-XV/FCD/2020-25, dated 1.06.2020 for the implementation of the recommendations on Rural Local Body(RLB) grants contained in Chapter 5(Local Body Grants) of the 15<sup>th</sup> Finance Commission (FC-XV) Report.
- 11. This order issues with the concurrence of Finance Department vide its U.O. No.23523/Fin(RD)/2020,dated 25.07.2020.
