NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume – III of the Tamil Nadu Services Manual, 1970).

2. The amendments hereby made shall be deemed to have come into force on the 3rd September 2014.

AMENDMENTS.

In the said rules, in rule 5-C,-

(1). sub-rule "(b)" shall be numbered as "(b) (i)";

(2). after clause (i) of sub-rule (b) as so numbered, the following clause shall be added, namely:-

"(ii) From the year 2015-2016, every 20th vacancy shall be earmarked for Steno-Typist Grade-II and Steno-Typist Grade-II who had worked as such from 01.08.1992 to 21.02.2001 in a continuous manner, for promotion to the post of Superintendent or its equivalent in the departments concerned. This rule shall be in force until the last such person is considered for promotion to the post of Superintendent or its equivalent".
