ORDER:

In the Government order first read above, the Government have ordered for pooling of the Assigned Revenue due to Rural Local Bodies from the proceeds of Local Cess, Local Cess Surcharge, Surcharge on Stamp Duty and Entertainment Tax (except Social Forestry receipts and income from Mines and Minerals) at the State Level and apportioning the same to the Rural Local Bodies.

2. In the Government Order second read above, the Government have accorded to sanction for release of a sum of Rs.904,74,09,957/- (Rupees Nine hundred and four crore seventy four lakh nine thousand nine hundred and fifty seven only) being the 50% of Total Grant under Pooled Assigned Revenue for the year 2024-25.

3. In the Government Order third read above, the Government have accorded to sanction for release the second and final installment of a sum of Rs.515,58,15,000/- (Rupees Five hundred and fifteen crore fifty eight lakh and fifteen thousand only) being the 50% of Total Grant under Pooled Assigned Revenue for the year 2024-25.

4. In the Government Order fourth read above, the Government have accorded sanction for a sum of **Rs.2109,48,21,000/-** and release the first installment of Rs.1054,74,10,500/- being the 50% of Total Grant under Pooling of Assigned Revenue for the year 2025-26.

5. In the letter fifth read above, the Commissioner of Rural Development and Panchayat Raj has sent a proposal to release of Pooled Assigned Revenue for the year 2025-2026 and **requested the Government to issue necessary orders** for the following:-

- a) To accord sanction for the total sum of **Rs.2409,19,60,984/- (Rupees Two Thousand Four Hundred and Nine Crore Nineteen Lakh Sixty Thousand Nine Hundred and Eighty Four only)** towards Pooled Assigned Revenue for the year 2025-26.
- b) To assign one-third of the total pooled amount to Village Panchayats and Panchayat Unions and two-third amount for Priority Schemes in rural areas for 2025-26 as was done in the year 2024-25 taking into account of the infrastructure requirements in rural areas as mentioned below:

- c) To continue the existing ratio of 67:33 for the allocation of funds under Pooled Assigned Revenue to Village Panchayats and Panchayat Unions respectively by adopting multiplier factor given by the Sixth SFC in the financial year 2025-26.

- d) To accord permission for the release of one-third of the Pooled Assigned Revenue to Village Panchayats and Panchayat Unions based on the latest SFC formula and two-third of the pooled amount may be credited to the Scheme Component Fund for implementing priority works in rural areas.
- e) The amount sanctioned in para 5 (a) may be debited under the following Heads of Account:-

- f) The Commissioner of Rural Development and Panchayat Raj shall be hereby authorized to draw the above amount and release of entire one third of the allocation to Village Panchayats and Panchayat Unions (in the ratio of 67:33) based on the latest SFC formula and retain the balance two third of the total allocation for implementation of Specific Development Schemes in rural areas as per the guidelines.
- g) To release the Pooled Assigned Revenue for the year 2025-26 under the relevant Heads of Account as mentioned below:

6. The Government after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj for the Pooled Assigned Revenue for the year 2025-26 in detail, have decided to accept the same and issue the following orders:-

- i. Sanction is accorded for a sum of Rs.2109,48,21,000/- (**Rupees Two Thousand One Hundred and Nine Crore Forty Eight Lakh Twenty One Thousand only**) towards Pooled Assigned Revenue for the year 2025-26.
- ii. Sanction is accorded for release the second installment of **Rs.1054,75,10,500/- (Rupees One Thousand Fifty Four Crore Seventy Five Lakh Ten Thousand and Five Hundred only)** as per the Revised Estimate.
- iii. Permission is accorded to assign one-third of the total pooled amount to Village Panchayats and Panchayat Unions and two-third amount for Priority Schemes in rural areas for 2025-26 as was done in the year 2024-25 taking into account of the infrastructure requirements in rural areas as mentioned below:

- iv. The existing ratio of 67:33 for the allocation of funds under Pooled Assigned Revenue to Village Panchayats and Panchayat Unions respectively by adopting multiplier factor given by the Sixth SFC in the financial year 2025-26.
- v. Permission is accorded to release of one-third of the Pooled Assigned Revenue to Village Panchayats and Panchayat Unions based on the latest SFC formula and two-third of the pooled amount may be credited to the Scheme Component Fund for implementing priority works in rural areas.

- vi. The amount sanctioned in para 6 (i) and (ii) shall be debited under the following Heads of Accounts:-
