ORDER:

It has been represented to the Government that, the Tamil film titled, "Mundhirikadu" (முந்திரிக்காடு) produced and directed by Thiru.M.Kalanjiyam is rooted in social justice and equality and vividly portrays the various issues/crises in the society arising out of inter-caste marriages. Hence, the said film may be granted exemption from entertainment tax liability. The Government, after careful examination of the representations, have decided to accept the same.

2. Accordingly, under sub-section (2) of section 11 of the Tamil Nadu Local Authorities Entertainments Tax Act, 2017 (Tamil Nadu Act 20 of 2017), the Governor of Tamil Nadu hereby grants exemption to the Tamil film titled, 'Mundhirikadu' (முந்திரிக்காடு), from the liability to the Entertainment Tax payable, under the said Act.
