ORDER:-

In the Government order first read above, orders along with necessary guidelines were issued for the implementation of energisation of street light with solar energy for the year 2012-2013.

In the letter second read above, the Chairman and Managing Director, Tamil Nadu Energy Development Agency has sent a proposal and has requested the Government to issue certain amendments and to revise the cost for energisation of 20,000 street lights at a cost of Rs.39,62,52,887/- against the earlier sanction of Rs.52.83 Crores.

3. In his letter third read above, the Director of Rural Development and Panchayat Raj has recommended the proposal of the Chairman and Managing Director, Tamil Nadu Energy Development Agency and requested the Government to issue revised orders in this regard.

4. The Government have examined the request of the Chairman and Managing Director, Tamil Nadu Energy Development Agency and Director of Rural Development and Panchayat Raj and decided to accept them. Accordingly, the Government issue the following amendments to the G.O.(Ms) No.67, Rural Development and Panchayat Raj (SGS 3) Department, dated 2.8.2012 along with guidelines.
