ORDER:

The Hon'ble Minister (Municipal Administration & Rural Development, Implementation of Special Programme) has made the following announcement on the floor of the Assembly on 04.06.2018.

‘ஊரக உள்ளாட்சி அமைப்புகளின் பணப்பரிவர்த்தனைகளில் வெளிப்படைத் தன்மையைக் கொண்டு வரும் வகையிலும், கண்காணிப்பினை மேம்படுத்தும் வகையிலும், மாண்புமிகு இதயதெய்வம் புரட்சித்தலைவி அம்மா அவர்களின் ஆசியுடன், மாண்புமிகு முதலமைச்சர் அவர்களின் ஆணைப்படி, இவ்வாண்டு முதல் ஊரக உள்ளாட்சி அமைப்புகளின் பணப்பரிவர்த்தனைகள் பொது நிதி மேலாண்மை அமைப்பின் (PFMS) கீழ் கொண்டு வரப்படும். இதன் மூலம் ஊரக உள்ளாட்சி அமைப்புகளின் பணப்பரிவர்த்தனைகள் நிகழ்நேர கண்காணிப்புக்கு உட்படுத்தப்படும்.’

2. The Director of Rural Development and Panchayat Raj in his letter second read above has stated that the Government of India has instructed the State Governments to switch over from the existing financial system to Public Financial Management System (PFMS) in respect of Fourteenth Central Finance Commission Grants to Village Panchayats. Accordingly, the State Scheme Manager (Director of Rural Development and Panchayat Raj), Mother and Child level agencies were created in respect of Rural Development and Panchayat Raj Department in (PFMS) Platform.

3. The Director of Rural Development and Panchayat Raj has further stated that as per the announcement of the Honourable Minister of Rural Development and Panchayat Raj on the floor of the Assembly all the accounts of the Village Panchayats, Block Panchayats and District Panchayats has to be brought into the Public Financial Management System Platform to ease the transparency and accountability in the financial transactions of Rural Local Body Accounts. In this regard, the accounts of the Village Panchayats need to be integrated with the Public Financial Management System Platform. The inclusion of the schemes like State Finance Commission grant in Public Financial Management System Platform

requires concurrence of the Finance Department of Government of Tamil Nadu. By implementing this, the Government of Tamil Nadu will be the only State in the Country which brought all this financial transactions of Rural Local Bodies under Public Financial Management System (PFMS) platform.

4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to authorize him to access the Public Financial Management System Platform to monitor financial transactions of Village Panchayats, Block Panchayats and District Panchayats Accounts and also to suitably instruct the State Project Management Unit of Public Financial Management System to create scheme registration and to provide necessary technical support in this regard.

5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj decided to accept the same. Accordingly, the Director of Rural Development and Panchayat Raj is authorized to access the Public Financial Management System Platform to monitor financial transactions of the three tier Panchayats to ease the transparency and accountability in the financial transactions of the Rural Local Bodies Accounts and to instruct the State Project Management Unit of Public Financial Management System to create Scheme Registration and also to provide necessary technical support in this regard.

6. This order issues with the concurrence of Finance Department vide U.O.No.31127/RD/18, dated 05.07.2018.
