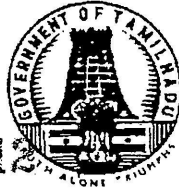
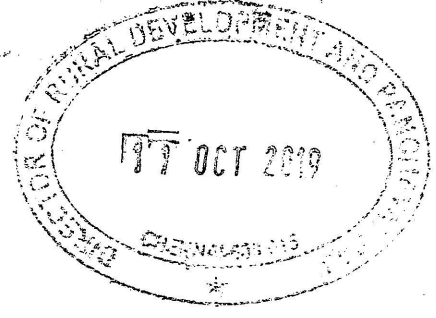

Land Alienation - Krishnagiri District – Barugur Taluk – Varattanapalli Village – Survey Number 475 - An extent of 0.70.0 hectare out of 1.17.5 hectares - classified as “ Battai Poramboke ” - Excluded from the operation under section 125(2) of the Tamil Nadu Panchayat Act 1994(Tamil Nadu Act 21 of 1994) - Notification - Issued.

ORDER:

In the letter first read above, the District Collector, Krishnagiri has sent proposal for alienation of the land to an extent of 0.70.0 hectares in S.No.475 out of the total extent of 1.75.5 hectares classified as “Battai Poramboke” in favour of TANGEDCO for formation of sub-station. The president of Varattanapalli Panchayat had passed resolution to alienate the above said land.

2. In the letter second read above, the Additional Chief Secretary / Commissioner of Land Administration has recommended to alienate the land and furnished the draft withdrawal Notification. In the letter fourth read above, the Director of the Rural Development and Panchayat Raj has accorded No Objection Certificate to alienate the land

to an extent of 0.70,0 hectares out of the total extent of 1.75.5 hectares in S.No.475 classified as "Battai Poramboke" as the Village Panchayat passed resolution and the District Collector also recommended for alienation.

3. The Government after careful examination, proposed to issue withdrawal notification to exclude the proposed land from operation of the Panchayat by notification under sub-section (2) of section 125 of Tamil Nadu Panchayat Act, 1994. (Tamil Nadu Act 21 of 1994) Accordingly, in exercise of the powers conferred by sub-section (2) of Section 125 of the Tamil Nadu Panchayat Act, 1994, (Tamil Nadu Act 21 of 1994), the Government exclude the land situated within the boundaries of the Varattanapalli village, Bargur Taluk, Krishnagiri District in Survey Number 475 to an extent of 0.70 hectares out of the total extent of 1.75.5 hectares which are classified as "Battai Poramboke" from the control of the Panchayat for alienation of land in favour of TANGEDCO for formation of sub-station.

4 The appended Notification will be published in the Tamil Nadu Government Gazette dated 03.09.2019.
