**ORDER:**

In the letter first read above, the District Collector, Theni has proposed to transfer the land of Survey Number 574/4 to an extent of 0.08.0 hectares out of the total extent of 0.78.0 hectare, classified as “ Government Poramboke Vandi Pathai ” in Kodangipatti Village, Bodinayakanur Taluk, Theni District for construction of New Building for the Veterinary Dispensary in favour of Animal Husbandry Department. The Village Panchayat had also passed resolution to transfer the above said land.

2. In the letter second read above, the Additional Chief Secretary/ Commissioner of Land Administration has forwarded the draft withdrawal notification. The Government after careful examination, proposed to issue withdrawal notification to exclude the proposed land from operation of the Panchayat by notification under sub-section (2) of section 125 of the Tamil Nadu Panchayat Act, 1994. (Tamil Nadu Act 21 of 1994).

Accordingly, in exercise of the powers conferred by sub-section (2) of Section 125 of the Tamil Nadu Panchayat Act, 1994, the Government exclude the land situated within the boundaries of the Kodangipatti Village, Bodinayakanur Taluk, Theni District in Survey Number 574/4 (proposed sub division 574/7) to an extent of 0.08.0 hectares out of the total extent of 0.78.0 hectares which are classified as Vandipathai from the control of the Panchayat for the land transfer in favour of Animal Husbandry Department for the construction of New Building for the Veterinary Dispensary.

3. In the letter third read above, the Director of the Rural Development and Panchayat Raj has accorded No Objection Certificate to transfer the land in Survey Number 574/4 (proposed sub division 574/7) to an extent of 0.08.0 hectares out of the total extent of 0.78.0 hectares classified as "Government Poramboke Vandi Pathai" which are classified as Vandipathai as the Village Panchayat passed resolution and the District Collector also recommended for transfer.

4. The appended Notification shall be published in the Tamil Nadu Government Gazette ordinary dated 20.09.2019.
