ORDER:

In the letter first read above, the District Collector, Theni has proposed to transfer the land to an extent of Survey Numbers 2614 and 2638/1 to an extent of 0.84.0 hectares out of the total extent of 1.67.5 hectares classified as "Government Poramboke Vandil Pathai" for the construction of Saruthupatti Government High School Building and Play Ground in favour of School Education Department. The president of Saruthupatti Panchayat had passed resolution to transfer the above said land.

2. In the letter second read above, the Additional Chief Secretary / Commissioner of Land Administration has recommended to transfer the land. In the letter third read above, the Director of the Rural Development and Panchayat Raj has accorded No Objection Certificate to transfer the land Survey Numbers 2614 and 2638/1 to an extent of 0.84.0 hectares out of the total extent of 1.67.5 hectares classified as

"Government Poramboke Vandl Pathai" as the Village Panchayat passed resolution and the District Collector also recommended for alienation.

3. In the letter fourth read above, the Additional Chief Secretary/ Commissioner of Land Administration has forwarded the draft withdrawal notification. The Government after careful examination, proposed to issue withdrawal notification to exclude the proposed land from operation of the Panchayat by notification under sub-section (2) of section 125 of Tamil Nadu Panchayat Act, 1994. (Tamil Nadu act 21 of 1994) Accordingly, in exercise of the powers conferred by sub-section (2) of Section 125 of the Tamil Nadu Panchayat Act, 1994. (Tamil Nadu act 21 of 1994) the Government exclude the land situated within the boundaries of the Thamaraikulam Village, Periyakulam Taluk, Theni District in Survey Numbers 2614 and 2638/1 to an extent of 0.84.0 hectares out of the total extent of 1.67.5 hectares which are classified as "Government Poramboke Vandlpathai" from the control of the Panchayat for the land alienation in favour of School Education Department for the construction of Building and Playground of Saruthupatti Government High School on free of cost with the following conditions:-

- 1) Stone charges, sub division charges etc., should be collected from the requisitioning department.
- 2) The requisitioning department should abide by all the conditions imposed by the Government and the land should be used only for the purpose for which it is transferred
- 3) The requisitioning department should return the land or part thereof to the Revenue Department if it is no longer required.

4. The appended Notification will be published in the Tamil Nadu Government Gazette dated the 28.06.2019.
