ORDER:

In the Government Order first read above, orders were issued releasing an amount of Rs.876.93 Crore as first instalment of General Basic Grant to Rural Local Bodies as recommended by the Fourteenth Finance Commission for the year 2018-19 and to utilise the General Basic Grant in conformity with the guidelines issued in G.O (Ms) No.107, Rural Development and Panchayat Raj (PR-1) Department, dated 21.09.2017.

2. In the letter 2nd read above, the Ministry of Finance, Department of Expenditure, Government of India, has released a sum of Rs.876.94 Crore as 2nd instalment of General Basic Grant to Rural Local Bodies as recommended by the Fourteenth Finance Commission for the year 2018-19.

3. The Director of Rural Development and Panchayat Raj in his letter 3rd read above has stated that the Department of Expenditure, Ministry of Finance, Government of India, has released the 2nd instalment of Basic Grant amount of Rs.876.94 Crore for the year 2018-19 vide its letter 2nd read above with a request to ensure that grants are distributed to the Village Panchayats as per the approved formula recommended in the latest State Finance Commission report.

4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to release a sum of Rs.876.94 Crore as second instalment of General Basic Grant to Rural Local Bodies as recommended by the Fourteenth Finance Commission for the year 2018-19.

5. Based on the release of the second instalment of the General Basic Grant for the year 2018-19 by Government of India, the Government now sanction and release a sum of Rs.876.94 Crore (Rupees Eight Hundred and Seventy Six Crore and Ninety Four Lakhs only) as second instalment of General Basic Grant to Village Panchayats, as recommended by the Fourteenth Finance Commission for the year 2018-19.

6. The expenditure sanctioned at para 5 above shall be debited to the following head of account:-

"3604-00-Compensation and Assignments to Local Bodies and Panchayat Raj Institutions – 198- Assistance to Gram Panchayats – Central Sector's Scheme SA. Basic Grants to Village Panchayats as per the recommendations of the 14th Finance Commission – 09 Grant-in-aid 01- Grants for Current Expenditure. (DPC-3604-00-198-SA-0910)"

7. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 5 above to all the Village Panchayats and the Grant shall be utilized in conformity with the guidelines issued in the G.O.(Ms)No.107, Rural Development and Panchayat Raj (PR-1) Department, dated 21.09.2017. He is also requested to furnish necessary utilization certificate towards the utilization of funds sanctioned in para 5 above in the prescribed format immediately for forwarding the same to the Government of India.
