### ORDER:

In the letter read above the Commissioner of Rural Development and Panchayat Raj has stated that as per National Panchayat Awards Guidelines 2023 (Para 3.2), the National Panchayat Awards include the three Special Category of Awards viz., (1) the Gram Urja Swaraj Vishesh Panchayat Puraskar, (2) Carbon Neutral Vishesh Panchayat Puraskar and (3) Panchayat Kshamta Nirmaan Sarvottam Sansthan Puraskar and the Ministry of Panchayat Raj instructed to constitute the Nomination Committees by States for the above three awards.

2. The Gram Urja Swaraj Vishesh Panchayat Puraskar will be given to 3 Gram Panchayats for their performance regarding adoption and usage of renewable sources of energy. The Carbon Neutral Vishesh Panchayat Puraskar will be given to 3 Gram Panchayats for achieving Net-Zero carbon emissions. The Panchayat Kshamta Nirmaan Sarvottam Sansthan Puraskar will be given to 3 institutions who have supported to Gram Panchayats in achieving Localization of Sustainable Development Goals.

3. The Commissioner of Rural Development and Panchayat Raj has, therefore, requested the Government to constitute the Nomination Committees as per Ministry of Panchayat Raj guidelines for 3 Special Category of awards.

4. After careful examination, the Government decided to accept the proposal of the Commissioner of Rural Development and Panchayat Raj and constitute the Nomination Committees for three Special category of Awards under National Panchayat Awards viz., Gram Urja Swaraj Vishesh Panchayat Puraskar, Carbon Neutral Vishesh Panchayat Puraskar and Panchayat Kshamta Nirmaan Sarvottam Sansthan Puraskar as follows:-
