



ABSTRACT

Establishment – Tamil Nadu State Election Commission – Permission to Tamil Nadu State Election Commission to relax the educational qualification prescribed in rule 5 of Tamil Nadu State Election Commission Rules 2002 for appointing Thiru.S.Vijayaraman, Punch Operator in the Department of Economics and Statistics as Computer Programmer in Tamil Nadu State Election Commission by recruitment by transfer – Orders – Issued.

In the Government order first read above, one post of Computer Programmer has inter-alia sanctioned to Tamil Nadu State Election Commission and the post continuance for the post was ordered upto 30.06.2016 vide Government order second read above.

2. The Secretary, Tamil Nadu State Election Commission in her letter fourth read above has stated that the qualification and mode of recruitment prescribed in the Tamil Nadu State Election Commission Service Rules, 2002 for the said post is as follows:-

Method of Appointment	Qualifications
By recruitment by transfer from any other service	i. Must possess B.E. Degree in Computer Science / MCA; and ii. Must have put in a service of not less than five years in the respective post in any Government Department.
Scale of pay	Rs.15600 – 39100 + 5700 GP

3. One Thiru.C.N.Shanmugaraj, was appointed on 27.05.2011 as Computer Programmer in the Commission on service lent basis from Civil Service Training Institute, Bhavanisagar, and he was relieved from the Commission on 11.05.2015 A.N., since then the post has been kept vacant in the Commission. Considering the

importance and urgency in filling up the post of Computer Programmer, the Commission took a stand to invite applications from the Departments requesting to send list of persons:-

- i. who are working as Computer Programmer possessing educational qualifications / scale of pay as prescribed in his parent Department for that post and willing to work in the Commission.
- ii. who have worked as Computer Programmer on deputation basis in some other department and now working in the parent department in his / her original post.

4. In the letter third read above, the Principal Secretary / Commissioner, Department of Economics and Statistics has forwarded the application of Thiru.S.Vijayaraman, Punch Operator, in the Scale of pay of Rs.9300-34800 + 4200 Grade Pay who is willing to work in the post of Computer Programmer in the Commission.

5. The Commission is satisfied that Thiru.S.Vijayaraman is capable to cater to the requirements of the Commission during the Ordinary Local Body Elections in October 2016 after perusing the details of having served as Computer Programmer in Home Department, Secretariat from 2008 to 2013. He does not possess the educational qualification i.e., BE/MCA as prescribed in the Service Rules of the Tamil Nadu State Election Commission whereas the said individual possess other technical qualification viz., Diploma in Computer Hardware from Baseline Technologies and other certificate qualifications and working experience.

6. Considering the dire necessity and urgency in filling up the post of Computer Programmer in the Commission before the onsetting of works related to the conduct of 2016 Ordinary Local Body elections, the Commission requested the Government to issue orders permitting the Commission to appoint Thiru.S.Vijayaraman, Punch Operator from the Department of Economics and Statistics as Computer Programmer in Tamil Nadu State Election Commission in the scale of pay of Rs.15600-39100+5700 GP by relaxing the educational qualification prescribed in the Service Rules of the Commission as 'one time measure'.

7. The Government after careful examination of the proposal of the Secretary, Tamil Nadu State Election Commission, issue orders permitting the Commission to appoint Thiru.S.Vijayaraman, Punch Operator in the Department of Economics and Statistics as Computer Programmer in Tamil Nadu State Election Commission in the scale of pay of Rs.15600-39100+5700 GP by relaxing the educational qualification prescribed in Rule 5 of Tamil Nadu State Election Commission Service Rules 2002 in favour of Thiru.S.Vijayaraman, Punch Operator as one time measure.
