### ORDER:

In the Government Order first read above, sanction was accorded for continuance of 54 temporary posts to Tamil Nadu State Election Commission from 01.07.2015 to 30.06.2016.

2. In the letter second read above, the Secretary, Tamil Nadu State Election Commission has sent the proposal to sanction the continuance for 54 posts for a further period of one year from 01.07.2016 to 30.06.2017 and stated as follows:-

- (i) The Tamil Nadu State Election Commission has to engage in the task of conduct of elections to 1,30,000 posts of Rural and Urban Local bodies in October 2016 and preliminary works have already been commenced for the conduct of elections. The Commission has actively engaged in the following pre election works:-
  - 1. Preparation and printing of Electoral roll
  - 2. Printing of huge quantity of Ballot papers for non-party elections
  - 3. Preparation and printing of Booth slips
  - 4. Printing of Statutory and Non Statutory forms
  - 5. Printing of covers
  - 6. Printing of guidelines and several instruction booklets
- (ii) The Commission has taken up the following important election related works also.
  - 1. Preparation of election manuals.
  - 2. Suggesting amendments to Acts and Rules.

- 3. Incorporation of Uniform provisions in Panchayat and Municipal Acts, Rules.
- 4. Simplification of election procedures.
- 5. Preparation of compendium of instructions issued by the Commission.
- 6. Preparation of compendium of important judgments on elections.
- 7. Improving of Tamil Nadu State Election Commission administration manual.
- 8. Updation of the Tamil Nadu State Election Commission website.
- (iii) As per the amendments to the Tamil Nadu Panchayats Act, 1994, the Tamil Nadu State Election Commission is empowered to conduct enquiries and to offer its opinion to the Government on the cases referred by the Inspector of Panchayats for disqualification. The Commission is conducting such enquiries regularly.

3. The Government have examined the proposal of the Tamil Nadu State Election Commission in detail and decided to sanction the further continuance of fifty four (54) Temporary posts which were last continued in the Government Order first read above. Accordingly, the Government accord sanction for the continuance of 54 Temporary posts as specified in the Annexure to this order, to the Tamil Nadu State Election Commission for a further period of one year from 01.07.2016 to 30.06.2017.

4. The posts sanctioned in para 3 above shall be eligible to draw Pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances as admissible under the orders in force.

5. The expenditure with regard to salaries of the above incumbents shall be debited to the following head of account:-

"2070-00-Other Administrative Services – 001. Direction and Administration – I. Non-Plan-AB. State Election Commission – 01. Salaries". (DPC 2070-00-001-AB-0106)
