NOTIFICATIONS BY GOVERNMENT

RURAL DEVELOPMENT AND PANCHAYAT RAJ DEPARTMENT

AMENDMENTS TO THE TAMIL NADU PANCHAYATS (ELECTIONS) RULES, 1995.

[G.O. (Ms.) No. 66, Rural Development and Panchayat Raj (PR-I), 24th June 2017.]

No. SRO A-29(c)/2017.

In exercise of the powers conferred by section 242 read with sections 11, 20, 32 and 57 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Panchayats (Elections) Rules. 1995:-

AMENDMENTS.

In the said Rules,-

- 1. in rule 26, after sub-rule (2), the following sub-rule shall be inserted, namely:-
- "(2-A) (a) Every candidate, at the time of filing his nomination paper for any election or casual election for electing a member to any Village Panchayat / Panchayat Union Council / District Panchayat or President of any Village Panchayat shall furnish full and complete information in an affidavit in Form 3-A:

Provided that having regard to the difficulties in swearing an affidavit in a village, a candidate contesting at the election to a Ward Member of Village Panchayat shall, instead of filing an affidavit, file before the Returning Officer, a declaration in Form 3-A.

(b) The said affidavit shall be duly sworn before a Magistrate of the First Class or a Notary Public or a Commissioner of Oaths appointed by the High Court of Madras or before an officer competent for swearing an affidavit. The affidavit shall be prepared in a Non judicial stamp paper of Rs.20/- (Rupees twenty only):

Provided that this clause shall not apply to a declaration filed under the proviso to clause (a) in Form 3-A.

(c) Non-furnishing of the affidavit or declaration, as the case may be, by any candidate shall be considered to be a violation of this rule and the nomination of the candidate concerned shall be liable for rejection by the Returning Officer at the time of scrutiny of nomination papers.

- (d) If more than one nomination has been filed by a candidate for an election, the affidavit or declaration, as the case may be, shall be annexed along with the first nomination and there is no need to furnish the affidavit or declaration, with the other nomination papers.
- (e) The information so furnished by each candidate in the aforesaid affidavit or declaration, as the case may be, shall be disseminated by the respective Returning Officers by displaying a copy of the affidavit or declaration on the notice board of his office and also by making the copies thereof available to all other candidates on demand and to the representatives of the print and the electronic media.
- (f) If any rival candidate has furnished any information to the contrary, by means of a duly sworn affidavit, then such affidavit of the rival candidate shall also be disseminated along with the affidavit or declaration of the candidate concerned in the manner prescribed in clause (e).
- (g) All the Returning Officers shall ensure that the format of the affidavit in Form 3-A shall be furnished to the candidates along with the forms of nomination papers as part of the nomination papers.
- (h) In view of the penal provisions contained in section 177 of the Indian Penal Code, 1860, in case of furnishing of false information by any candidate, if any, confirmed at a later date, the Returning Officer concerned may initiate criminal action against that candidate, after providing reasonable opportunity of hearing and by following the procedure contemplated in section 195 of the Code of Criminal Procedure, 1973.";
