### ORDER:

The Mission Director, National Health Mission in his letter read above among others has stated that, the committees to be constitute State Level, District Level and Block Level Committees under Ayushman Bharath Programme as detailed below:-

i. State Level Coordination Committee under the Chairperson of the Secretary, Health and Family Welfare with Co-Chairperson with the Secretary, School Education Department will be constituted to meet once in a year.

ii. A State Level Sub-Committee under the Chairpersonship of Mission Director (National Health Mission) will be constituted for better coordination with partner departments and will meet twice a year.

iii. The District Level Coordination Committee under the Chairmanship of District Collector will be constituted and will meet every quarter.

iv. The Block level committee will be constituted under the chairpersonship of Block Medical Officer with Co- Chairperson of Block Education Officer.

The above committees would ensure effective implementation of the programme and be actively involved in training of "Health and Wellness Ambassadors" (Nodal Teachers). The committee will ensure data flow from Schools to the District Level. The Mission Director, National Health Mission has furnished the details of the Committees to be constituted under Ayushman Bharat Programme and the roles and responsibilities of the committees and has requested the Government to issue necessary orders in this regard.

2. The Government after careful consideration have decided to constitute the co-ordination committees under Ayushman Bharath Programme as follows and orders accordingly.

The State Rashtriya Bal Swasthya Karyakram / Rashtriya Kishor Swasthya Karyakram (III).officer, Directorate of Public Health and Preventive Medicine is appointed as the Nodal person for all Planning, Trainings, implementation and Monitoring of the programme.

The Mission Director, National Health Mission is permitted to release the funds to the (IV). Director of Public Health and Preventive Medicine for implementation of the

programme in Ramanathapuram, Virudhunagar, Vellore, Ariyalur and Karur.

The Mission Director, National Health Mission is permitted to extend the State, District (V). and Block level Committee to other districts as when the School Health Programme under Ayushman Bharath Programme is extended to other Districts every year in ROP in Programme Implementation Plan of Government of India.
