ORDER:

In G.O.Ms.No.297, Home (Tpt.4) Department, Dated 25.02.2008 the Government have allowed the Secretaries / Special Secretaries to Government to purchase a vehicle of their choice by replacing their existing vehicles within a ceiling of Rs.8.50 lakhs.

2. Further there are certain instances wherein Collectors and Superintendents of Police have not had the resources to install one A/c in their Offices and Camp Offices owing to non-availability of funds for this purpose from other sources. The Government have now decided to extend the above facilities ordered in the G.O. second read above to all the District Collectors and Superintendents of Police in the State so as to enable them to purchase the vehicle of their choice within a ceiling of Rs.8.50 lakhs and also to provide A/c facilities at the rate of one A/c in the offices and camp offices of all the District Collectors and Superintendents of Police (if not even one A/c is available at present).

3. The District Collectors and Superintendents of Police are requested to surrender the existing vehicles to the Government in Public (M.V.) Department for the internal reallocation as soon as the new vehicle is purchased.


