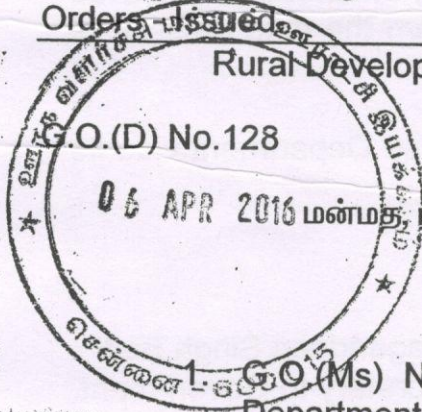

5. This order is issued with concurrence of Finance Department vide its U.O. No.11134/PC/2016, dated 29.2.2016.


