ORDER:

Government in the order first read above framed Adhoc rules for the post of Assistant Engineer from the post of Overseer/ Junior Draughting Officer by recruitment by transfer and subsequently made amendments in the Government Order fourth and fifth read above. The service qualifications under Rule 5 prescribed

for the post of Assistant Engineer from the post of Overseer / Junior Draughting Officer is as follows:-

Method of	Qualification
Appointment (1)	(2)
(b) Recruitment by Transfer	Must possess a B.E. Degree in Civil Engineering or must have passed Sections A and B of the Institution of Engineers (India) in Civil Engineering Branch and he should furnish evidence of having undergone practical training in surveying for a period of not less than one year; and
	2. Must have rendered service for a total period of not less than five years on duty as Overseer or Junior Draughting Officer either separately or put together in both posts.

- 2. Government in the order third read above framed adhoc rules for the post of Junior Engineer from the post of Overseer by promotion and as per the said Government Order, the service qualification is as follows:-
 - 5. Qualification:- No person shall be eligible for appointment to the posts, unless he possesses the following qualifications, namely:-
 - (i) Must possess a Diploma in Civil Engineering; and
 - (ii) Must have rendered service as Overseer for a period of not less than ten years.
- 3. The Hon'ble Chief Minister of Tamil Nadu has made an announcement under Rule 110 of Tamil Nadu Legislative Assembly Rules in the floor of the Assembly on 19.2.2016 with regard to the Overseers' service qualification for promotion as follows:-

Announcement

"ஊரக வளர்ச்சித் துறையில் பட்டயப்படிப்பு முடித்துள்ள மேற்பாள்வையாளர்களுக்கு, இளநிலைப் பொறியாளராகப் பதவி உயர்வு பெறுவதற்கான பணிக்காலத் தகுதி 10 ஆண்டுகளிலிருந்து 7 ஆண்டுகளாகக் குறைக்கப்படும். பொறியியல் பட்டப் படிப்பு முடித்துள்ள மேற்பாள்வையாளர்களுக்கு இப்பணிக்காலத் தகுதி 5 ஆண்டுகளிலிருந்து 4 ஆண்டுகளாகக் குறைக்கப்படும்"

- 4. As per the aforesaid Announcement made by the Hon'ble Chief Minister of Tamil Nadu, the Government order that the 10 years service qualification as Overseer with Diploma in Civil Engineering prescribed for promotion to the post of Junior Engineer is now reduced to 7 years. The Government further order that the 5 years service qualification as Overseer or Junior Draughting Officer with B.E. degree in Civil Engineering prescribed for the method of recruitment by transfer to the post of Assistant Engineer is now reduced to 4 years.
- 5. This order shall be deemed to have come into force with effect from 19.2.2016.
- Necessary adhoc rule amendment notification to this effect shall be issued separately.
